The Mayor called the meeting to order and led in the Pledge of Allegiance. The Clerk held the roll call.

Mayor Newhard made the following statement:

I am pleased to announce that the coming year's Village Budget will remain below the tax cap which, as set by the NYS Comptroller, is 1.78%.

One of the main costs we face is for Sewer Plant Improvements. The mechanism for collecting funds for this \$12 million dollar project is through the Sewer Plant Improvement Tax. The Village received a \$3 million dollar grant from NYS EFC, however the remaining cost to repay the anticipated 15-year loan will be through the Sewer Plant Improvement Tax. To that end, there will be no other land taxes collected for the Water or Sewer Fund for 2020-21. Part of covering these costs will be an 8% increase in Sewer usage rates. Water usage rates will remain the same.

Project Highlights For 2020-21

General Fund:

Central Garage - New generator, new truck lift

Special Items - Planning Consultant for the Village Comprehensive Plan

Parking lots - Upgrade of Spring Street lot, which will begin this year

Streets/Roads - New chipper, curb/sidewalk improvements for Country Lane, \$113,861 of road reclamation and improvements

Parks - New cameras slated for Stanley Deming, a new defibrillator Stanley Deming, repairs Over 35 field, Bocce ball courts in Memorial Park, and re-pavement for Memorial Park Drive. Storm Sewers - Wheeler Avenue culvert replacement, Maple Ave. trash rack repair

Water Fund:

Well #3 construction, replace T-1 tank and 3 on-line turbidity meters at Water Treatment Plant Water Pump Stations - 4 portable gensets / storm emergency preparation, watermain and waterline repairs: River St and Robert Drive

Sewer Fund:

Genset installation at Robin Brae pump station

Sewer Plant Phase 1 Installation of UV System, Orchard St. pump station head works repair.

I believe that covers a lot of the highlights, actually there is more in the budget if you have an opportunity to take a look, but this includes all of the services and the things that we do on a yearly basis. I believe that we as a Village Board have defined a budget that includes really significant repairs throughout every part of our municipality for every different department and it includes the ongoing and anticipated services for the community. I want to thank of course, the

department heads for doing such a great job for putting their budgets together. They were very realistic, and we appreciate that, it made our job easier as a Board. I also want to thank Village Treasurer, Cathy Richards, and Village Accountant Michael Vernieri for helping us accomplish our goal, especially at remaining at below the tax cap this year. So, with that, I will give the floor to Michael Vernieri to add to my synapsis.

Michael Vernieri stated that he wanted to add what the Village has been talking about for the last few years and that is the use of the land tax that the Village has been using for the last ten years or so in order to take care of some of the Village's major projects. Since the Village has allowed to put money away with that land tax, as well as spending on some improvements, the Village was able in the new budget and the old budget, to pay off the Village's BAN's for the water department and reduce the BAN's for the sewer department. The whole idea, being to look forward to the sewer plant. The Village now wants to make sure that it has enough funds put aside so that the Village can maintain the fifteen-year requirement for which was approved last year in order to pay for the sewer plant. So, this particular year, because the Village did not have the need to put any of the sewer land tax into water, the Village decided it was going to put it all into the sewer plant which will now give the Village roughly a \$1.4 million dollars towards that sewer plant for which the Village is going to need a significant amount more. Mr. Vernieri expressed that he is hoping that the Village can continue this process with the sewer land tax and the regular land tax in order to get to the goal of fifteen-years or less to pay off the sewer plant. Mr. Vernieri remined everybody that the Village has used this process before. The water plant has now been paid in full upon its completion because the Village followed through on this and the Village is continuing this process with the sewer plant at the same time being able to fund the rest of the Village's needs in both water and sewer. The 8% increase in the sewer rates specifically is designed so that the Village knows when the sewer plant comes online there will be additional expenses – we are preparing for that rather than getting a huge increase the year that plant is opened, so the Village is preparing for that as well. In summary, as the Mayor has indicated, not only has the Village balanced the budget without using any of the reserved funds, the Village has also planned for the future and is looking long term as well as short term and are hoping that this is a formula that is going to work with the Village even in these times.

Mayor Newhard opened the floor to the public. No comments were made.

Correspondence

1. Letter from Village Engineer, Lehman & Getz regarding the flow monitoring study of the Village's sanitary sewer system.

Trustee Cheney stated that the letter explained that this is something the DEC has been pushing the Village to install these flow meters in select manholes throughout the collection system to find areas of infiltration and inflow so that those can be corrected. A year ago, the Village submitted for a \$100,000 grant and was not successful. The Village intends to apply again this year with data and possible specific corrective actions, we hope will be more successful this year. We will also seek a debriefing of the Village's application last year to see how the Village might be able to strengthen it in order to be successful. The firm is planning to be in the Village tomorrow and Wednesday installing those meters and they will begin collecting data immediately, so we are hoping for rain. The more rain we get, the more effective the information is that we receive.
