The Regular Meeting of the Board of Trustees of the Village of Warwick was held on Monday, April 21, 2025, at 7:30 p.m. in Village Hall, 77 Main Street, Warwick, NY. Present was: Mayor, Michael J. Newhard. Trustees: Barry Cheney, Thomas McKnight, and Mary Collura. Also, present was Village Clerk, Raina Abramson and Village Attorney, Stephen Gaba. Absent was Trustee, Carly Foster. Others present, Police Chief, John Rader, and other.

The Mayor called the meeting to order and led in the Pledge of Allegiance. The Village Clerk held the roll call.

1. Police Report.

Warwick Police Chief John Rader reported that the department recently participated in Career Day at Warwick High School as part of its ongoing recruitment efforts, which align with recommendations from the executive order on police reform. These efforts aim to encourage local high school students to pursue careers in criminal justice. The department maintains a year-round relationship with the school, which also allows the use of a classroom for the Junior Police Academy. Chief Rader noted that the summer session dates for the academy had been announced and would be posted on social media once available.

He reminded the Board that the Little League Parade would take place on Saturday with a 10:00 a.m. step-off. Officers would be present to manage detours and delays.

Chief Rader also introduced seven new part-time officers at the previous meeting, explaining that this coincided with a recent policy change allowing officers to work with both the Village of Warwick and the Village of Greenwood Lake. He emphasized that both departments are accredited and share the same third-party policy manual, making the transition seamless.

Among the new officers, Chief Rader highlighted Officer Ava Smith, a graduate of the Rockland Police Academy who works in Greenwood Lake. Officer Ryan Warden and Officer Michael Warden, identical twins who both graduated from the Ulster Police Academy, were also introduced.

Mayor Newhard requested that Chief Rader bring the newly appointed part-time police officers to a future Board meeting so they could be formally introduced. Chief Rader agreed and expressed that he would be happy to arrange it.

Chief Rader shared that he recently conducted a foot patrol with Officer Ava Smith, visiting local businesses in the Village. He confirmed that he would bring the new officers to an upcoming meeting so the Mayor could meet them in person.

He went on to introduce additional part-time officers: Officer Justin Ray Burch, who also works with the Village of Greenwood Lake; Officer Sean Allen, who graduated from the Orange County Police Academy and completed part of his training at the Rockland

Police Academy; and Officer Alexander Rajkowski, a recent graduate of the Orange County Police Academy and recipient of the Defensive Tactics Award.

Chief Rader gave special recognition to Officer Sean Walter, another graduate of the Orange County Police Academy, who served as class president and received multiple honors: the Excellence in Emergency Medical Care Award, the Drill Instructor's Award, the Overall Achievement Award, and the Chief and Detective James T. Geary Father and Son Memorial Award for Academic Achievement. This final award included a \$500 grant, which Officer Walter plans to donate in his name to a law enforcement-related cause.

Chief Rader also announced the department's recent purchase of Guardian language translators, a significant step toward improving communication with non-English-speaking residents. These devices can translate 144 languages when connected to Wi-Fi and 16 languages offline. A recent real-world example illustrated the devices' effectiveness: an officer used one during a traffic stop involving a Venezuelan family from Queens. The translator helped officers communicate clearly and arrange a safe ride for the family after vehicle violations prevented them from driving, helping to ease a potentially stressful situation.

Mayor Newhard praised the addition of the Guardian language translators, calling them a wonderful tool. He expressed his appreciation for the department's efforts to enhance communication and support within the community.

Chief Rader offered to visit Village Hall to demonstrate the Guardian language translator device, noting that it utilizes AI technology and provides near-instant translations. He explained that each police post will have a device, along with units in dispatch, with detectives, and even one stationed at Town Hall. He recommended the Village consider acquiring one for broader municipal use, emphasizing its simplicity—two buttons allow for seamless two-way communication between English and the selected language. He recounted how the translator helped facilitate multiple return visits from the same Venezuelan family seeking to retrieve their vehicle, making the interactions smooth and stress-free. Chief Rader noted that the device performs more effectively than Google Translate in real-time situations.

Mayor Newhard agreed with Chief Rader's recommendation, noting the increasing number of international visitors to the Hudson Valley. He acknowledged the importance of having tools like the Guardian language translator to better serve both residents and visitors who speak different languages.

Chief Rader further highlighted the capabilities of the Guardian language translator, noting that it includes 11 different dialects for Spanish alone. He emphasized how this

feature allowed officers to tailor communication specifically to the Venezuelan family they assisted, greatly improving understanding and comfort during their interaction.

Announcement

1. The Village of Warwick Celebrates Arbor Day 2025 on Friday, April 25, 2025, at 9:00 a.m. at Staley-Deming Park.

Mayor Newhard elaborated on the upcoming tree planting event that the Village shares annually with the Warwick Valley Gardeners and Park Avenue Elementary School. The event includes participation from all third-grade classes and features poems, songs, and a public tree planting ceremony. He invited the public to attend and noted that it is a festive and meaningful tradition. This year marks the Village's 41st year as a designated Tree City.

Discussion

1. Wickham Works Stanley-Deming Park proposed mural design.

Mayor Newhard provided an update on the Wickham Works mural project in Stanley Deming Park, noting that the concept, which had been discussed previously, is now moving forward. He recalled a suggestion from Trustee McKnight that additional areas in the park could serve as potential mural locations. Wickham Works explored the park further and identified a suitable spot on the exterior of the bathroom building. The location features two large, empty framed sections facing the street—ideal for a mural. The Mayor highlighted that the placement would ensure high visibility for both pedestrians and passing drivers, enhancing the park's visual appeal.

Trustee McKnight expressed appreciation for the proposed mural and emphasized the importance of preserving existing artwork at the handball court, even though it is beginning to show signs of weathering after five years. He noted that the artwork continues to hold value for the community, as people still stop to take pictures there, underscoring its lasting impact.

Mayor Newhard noted that in addition to the two framed spaces facing the street, there is a frieze of empty sections around the entire bathroom building that could also be utilized for murals. He suggested that extending the artwork across these areas would create a richly decorated and visually striking structure. The Mayor asked if everyone had seen the proposed design and shared that he felt the work was beautiful. He praised the artist's talent, noting the impressive level of artistry and the visual impact the completed mural could have.

Mayor Newhard announced the launch of the Village's pilot Artist-in-Residence program, sharing that artist Nicole Hickman has begun setting up her workspace along the stream in Stanley Deming Park. He invited Trustee Mary Collura to elaborate on the project, noting that she was familiar with the artist's plans and could provide further insight into the activities taking place.

Trustee Collura provided details about Nicole Hickman's Artist-In-Residence project, explaining that the installation will feature a sculpture representing the divine feminine, created from a large willow stump. The sculpture will take the form of a woman with strawberries growing from her hair, symbolizing nourishment and community care. She noted that the installation is temporary and will remain in place for a few weeks. During that time, the public is welcome to visit the site and enjoy the experience of eating the sculpture's strawberries.

Mayor Newhard added that the divine feminine sculpture by Nicole Hickman will also include an educational component. In addition to its artistic and symbolic elements, the installation will serve as an opportunity for community learning and engagement, further enhancing its value as part of the Artist-in-Residence program in Stanley Deming Park.

Trustee Collura noted that artist Nicole Hickman is actively involving community members and children in various aspects of the project, including planting and other hands-on activities. She announced that the official kickoff for the Artist-in-Residence installation will take place on Saturday during the Treecycle event.

Mayor Newhard emphasized that Saturday would be a particularly busy day in the Village. In addition to the Treecycle event, the Little League parade and Project Clean Sweep would be taking place Saturday, making for a full schedule of community activities.

Trustee Cheney added that the Daisy Scouts would be selling cookies on Railroad Green.

GUIDELINES FOR PUBLIC COMMENT

The public may speak only during the meeting's Public Comment period and at any other time a majority of the Board allows. Speakers must be recognized by the presiding officer, step to the front of the room/microphone, give their name, residency, and organization, if any. Speakers must limit their remarks to three minutes (this time limit may be changed to accommodate the number of speakers) and may not yield any remaining time they may have to another speaker. Board members may, with the permission of the mayor, interrupt a speaker during their remarks, but only for the purpose of clarification or information. The Village Board is not required to

GOVERNING BODY FAIR HOUSING RESOLUTION

The Village of Warwick supports the Fair Housing Act (42 USC 3601) which prohibits discrimination by direct providers of housing such as landlords and real estate companies as well as other entities, such as municipalities, banks or other lending institutions and homeowners insurance companies whose discriminatory practices make housing unavailable to persons because of: race, color, religion, sex, national origin, nationality, familial status, or disability. This municipality further objects to discrimination in the sale, rental, leasing, financing of housing or land to be used for construction of housing, or in the provision of brokerage services because of race, color, religion, sex, national origin, nationality or disability as prohibited by Title VIII of the Civil Rights Act of 1968 (Federal Fair Housing Law). Therefore, the Municipal Council does hereby approve the following resolution.

BE IT RESOLVED, that within available resources, the municipality will assist all persons who feel they have been discriminated against under one of the aforementioned categories, to seek equity under federal laws by filing a complaint with the New York State Human Rights Law and the U.S. Department of Housing and Urban Development, as appropriate.

BE IT FURTHER RESOLVED, that the municipality shall publicize this resolution and through this publicity shall cause owners of real estate, developers, and builders to become aware of their respective responsibilities and rights under the Federal Fair Housing Law.

BE IT FURTHER RESOLVED, that the municipality will at a minimum include, but not be limited to:

- (1) the printing and publicizing of this resolution, a fair housing public notice and other applicable fair housing information through local media, community contacts and placement on the Municipal website and in other social media;
- (2) distribution of posters, flyers, and any other means which will bring to the attention of those affected, the knowledge of their respective responsibilities and rights concerning fair housing.

Discussion

Trustee Cheney raised a question about the implementation of one of its conditions. He pointed to a section stating that the Village must, at a minimum, distribute posters, flyers, and other materials to inform those affected of their rights and responsibilities under fair housing laws. Trustee Cheney asked whether there had been any consideration of how this outreach would be conducted, noting the importance of reaching realtors and property owners as part of the effort.

Village Attorney Stephen Gaba responded to Trustee Cheney's concern, explaining that while the resolution does call for distributing materials, it does not necessarily require direct, in-person outreach. He clarified that compliance could be achieved by making the materials available at the Clerk's Office and sending out an email notice offering them to interested parties, such as realtors or property owners. He emphasized that there is no need to go door to door to meet the requirements of the resolution.

Trustee Collura stated that the information had been included in the Village newsletter, which she believed fulfilled the outreach requirement outlined in the resolution.

Village Attorney Gaba recommended that, in addition to the newsletter, the Village should post the fair housing information on its website.

Trustee Cheney expressed appreciation for the effort involved, acknowledging the persistence it took to engage Chase and move the process forward. He then asked whether every Village fund is required to go through a formal resolution process in order to authorize spending, referencing the procedure followed for the recent motions.

Village Attorney Gaba explained that if a fund is designated as a capital reserve, then formal resolutions are required to authorize spending from it.

Trustee Cheney used the Parkland Fund as an example, noting that he did not believe it was classified as a capital reserve fund. He then questioned why the Parking Fund is treated as such.

Attorney Gaba replied that, according to the Village Treasurer, the Parking Fund is considered a capital reserve. Trustee Cheney expressed uncertainty about whether that classification was originally intended and suggested that the matter should be reviewed further.

Mayor Newhard elaborated on the funding sources referenced in the resolution for the Village's purchase of the Chase Bank parking lot. He explained that the Parking Lot Reserve Fund is primarily built from the quarters collected at Village parking meters, which have accumulated over time to create a dependable funding source. When the Village learned that the Chase property was for sale, this reserve positioned them to act. He also noted that the Village received a \$50,000 grant from Senator James Skoufis, which helped finalize the purchase. Mayor Newhard emphasized the significance of the lot as part of the Village's overall parking infrastructure, calling it a valuable asset similar to other municipal lots, especially the South Street lot. He expressed gratitude that the Village is able to move forward with the acquisition, stating that "parking is king" in a vibrant downtown like Warwick's.

Trustee McKnight expressed his gratitude to those involved in securing the Chase Bank parking lot for the Village. He acknowledged the years of discussions and the difficulty of the negotiations, noting that the process was far from easy. He remarked that the Village was fortunate to be able to preserve this important piece of property, especially considering that the sellers had initially been reluctant to sell.

Mayor Newhard confirmed that the Chase Bank ATM located on the property will remain in operation. As part of the agreement, the Village will enter into a lease with Chase Bank to allow continued use of the ATM, ensuring ongoing access for residents and visitors.

Trustee McKnight explained that it is a local business that has expanded nationally and is already in use by organizations such as Monroe and Tuxedo for their recreation programs. He and Trustee Collura reviewed the platform, with Trustee McKnight focusing on its technological capabilities. He explained that the previous registration software used by the Village struggled with high traffic volumes, making it difficult for parents to sign their children up for summer recreation programs. In contrast, BeClutch is a modern web application designed to handle greater capacity, and he expressed confidence in its ability to meet the Village's needs. He looked forward to its rollout for the upcoming camp season.

Trustee McKnight explained that, in addition to managing camp registrations, the BeClutch system will also replace the municipal ID system previously handled by the retiring software. He shared that the vendor successfully developed a solution to fulfill this need, allowing residents to obtain local IDs in a like-for-like manner. He added that the system could also be used to generate badges for recreation camp counselors. Another key feature he highlighted was the platform's communication capabilities. The new system will enable Recreation Director Ron Introini to maintain real-time contact with both counselors and parents—an improvement particularly helpful for communicating weather-related cancellations or delays.

Discussion

Trustee McKnight asked how the request came about.

Mayor Newhard explained that the amended Letter of Credit originated from the Planning Board process, during which the Planning Board attorney initially set the financial assurance amount. However, he acknowledged that the original amount was significantly inadequate. The Village later had the opportunity to revise the terms and recommend a more appropriate figure, prompting the current amendment to better protect the community's interests.

Trustee Cheney inquired whether there were any remaining hurdles preventing Warwick Energy Storage 3, LLC from beginning operations. He noted that he did not believe any obstacles remained, suggesting the project might now proceed following the amendment to the Letter of Credit.

Trustee McKnight followed up by asking whether Convergent had permission to begin operations.

Village Attorney Gaba responded that, according to repeated communications from Convergent Energy & Power LLP, all necessary components are in place, with one exception. The Mayor is required to sign a short form acknowledging acceptance of the amended Letter of Credit. Following that, the Letter of Credit must be officially filed with the Village Clerk. Once these final steps are completed, the company will be authorized to proceed.

Trustee McKnight asked how the moratorium previously passed by the Village impacts the operation.

Mr. Gaba explained that they are likely exempt from the Village's moratorium because the project had already received its approvals prior to the moratorium being enacted. As such, the restrictions outlined in the moratorium do not apply to this particular project.

Trustee McKnight asked for specific clarification on what actions Convergent must take in order to officially bring the battery storage units online.

Mr. Gaba stated that he was only familiar with the requirements necessary to bring the storage unit to the point where they are authorized to begin work. He indicated that he did not have details regarding the specific actions or steps the company must take to bring the system online.

Trustee McKnight expressed a desire for more clarity regarding the full scope of what needs to be done to bring the project online. He acknowledged that the current discussion pertained solely to the bond, but emphasized that the broader operational details should be addressed separately.

Trustee Cheney stated that the amended Letter of Credit was likely one of the conditions necessary to receive a CO (Certificate of Occupancy) from the Building Inspector. Without meeting this requirement, the project would not be allowed to begin operations.

Mr. Gaba confirmed.

Trustee McKnight requested clarification on the other conditions. He stated that it was his understanding there were several requirements beyond the amended Letter of Credit.

Trustee Cheney asked whether the remaining conditions referenced by Trustee McKnight were part of the original project approval or if they were additional requirements imposed following the battery storage unit fire incident.

Trustee McKnight responded that, to his understanding, the Village is still working under the original conditions established at the time of project approval.

Trustee Cheney stated his understanding that all original conditions of approval had been satisfied and that preparations for operation were already underway.

Trustee McKnight clarified that, prior to the fire incident, the units had not been officially brought online but were in a testing phase. He noted that the fire occurred during this preliminary stage, before full operation had commenced.

Mr. Gaba recommended that the Board request a memo from the Building Inspector, Boris Rudzinski to clarify the current status of the Convergent Energy project. He suggested contacting Boris directly to ask for a summary of any outstanding requirements.

Mayor Newhard noted that Keith Woodruff was believed to be involved in the process.

Mr. Gaba clarified that while Keith Woodruff reviewed the project, it is the Building Inspector who is responsible for issuing the CO. He explained that Boris would consult with Keith before making a final decision. Mr. Gaba advised that the Board could reach out to either or both individuals to obtain a clear update on the status of the Convergent Energy project.

Trustee McKnight expressed a preference to hold off on finalizing any action related to the project until a comprehensive review is completed. He emphasized the importance of revisiting the original set of conditions from the project's Planning Board approval, dating back to around 2019 when he served on the Planning Board. He stressed the need to understand how the fire incident affected those conditions, whether any revisions were made, and what the current status is.

Trustee McKnight reiterated the importance of consulting with the Village engineer and Building Inspector to ensure that all aspects of the Convergent Energy project have been properly addressed. He cautioned against the potential risk of the amended Letter of Credit being viewed as the final step, only for additional unresolved issues to emerge afterward. He stated that he would feel more comfortable moving forward if the Board had clear confirmation that all conditions had been reviewed and satisfied.

Trustee Cheney acknowledged Trustee McKnight's concerns but clarified that they were separate from the matter at hand. He emphasized that the current motion pertains specifically to the amended Letter of Credit, which Convergent Energy had been instructed to provide. Since they fulfilled this requirement, Trustee Cheney stated he did not see a basis for withholding approval of the motion.

Trustee McKnight agreed with Trustee Cheney in principle, acknowledging that if viewed in isolation, the motion to approve the amended Letter of Credit was valid. However, this approval could be perceived as the final step in a long and complex process leading to the issuance of a CO. He reiterated the need for a thorough review to ensure all prior conditions had been fully addressed.

Trustee Cheney proposed that the Board request a report from Building Inspector Boris before the CO is issued.

Trustee McKnight expressed discomfort with allowing the Building Inspector to issue a CO for the Convergent Energy project without the Board first receiving a comprehensive review. Citing the attention the project has received and the risks associated with the prior fire incident, he recommended that the Village engineer provide a memo confirming that all conditions have been re-evaluated and satisfied. He further suggested that the issuance of the CO should be subject to formal approval by the Village Board, even if that process is not typically required.

Trustee Cheney suggested that the Board enter into executive session to discuss the Convergent Energy matter further.
