Discussion

Trustee Patterson expressed concern about the road closure being moved up to South Street on Main Street, along with the closure at Spring and Wheeler, that the access to CVS and those shops was completely cutoff, along with access to the handicap parking in the lot. Discussion ensued with the Village Board regarding the placement of the barriers concerning safety and accessibility. DPW Supervisor, Mike Moser, explained that the placement of the barrier is an effort to divert traffic down South Street as a safety measure so cars don't continue down Main Street as well as to avoid bottlenecks, turnarounds, and other issues. Mayor Newhard requested that when the barriers are put out, to please be cognizant of the placement to still allow safe access to the CVS lot and Frank's pizza.

<u>Facility Use – Memorial Park Pavilion, McFarland Parking Lot & Railroad Green</u> <u>Warwick Valley Rotary Foundation</u>

Approval of form GC-RCF does not authorize the applicant to sell tickets at their leisure. All ticket sales during events and/or street fairs are subject to prior written approval of the event organizers and must be filed in the Clerk's Office. All other ticket sales are subject to prior written approval from the Village Board of Trustees.

Discussion

Trustee McManus inquired where the ticket sales will take place if Music for Humanity is not allowed to sell them at their leisure. Mayor Newhard explained, that if Mr. Adelman wanted to sell tickets at a street fair, he would have to contact the organizers for permission. Mayor Newhard stated that it is a matter of control so that the Village is aware of where and when tickets will be sold. Village Clerk, Raina Abramson, stated that after a conversation with the NYS Gaming Commission, approval of this document only provides geographic consent, so geographically the Village of Warwick is allowing Music for Humanity to sell raffle tickets however, Mr. Adelman still must follow whatever rules, procedures, or permits that the Village Board requests.

Further discussion ensued between Village Attorney, Stephen Gaba, and the Village Board regarding the approval.

Trustee Cheney further explained that this form is a requirement from the State, covering approximately twelve municipalities and even though Music for Humanity may receive general geographic approval covering these municipalities, Mr. Adelman still must comply with whatever requirements those municipalities have established for his sale of raffle tickets. Trustee Cheney explained it as a two-step process; step one gives Music for Humanity the ability through the State Gaming Commission to sell raffle tickets within our jurisdiction but sales can't take place unless the applicant complies with the other aspects of the motion.

Discussion

Alec Gladd from Cuddy & Fedder, LLP explained that the request is a simple renewal of AT&T's existing wireless facility on the St. Anthony Community Hospital where six antennas are maintained and mounted on the side of the building with supporting equipment platform on the roof. Mr. Glad stated that it is a 4G LTE site that was last upgraded in 2016 with no additional modifications proposed, except a possible discussion to extend the renewal period for longer than five years.

Village Attorney, Stephen Gaba, explained that by Code, five years is the maximum that can be granted. Mr. Gaba also stated that it has been confirmed by Building Inspector/Code Enforcement Officer, Boris Rudzinski, that there have been no complaints, no violations, and that the application provides all the required information. Mr. Gaba also explained that the Village Board does not have a lot of leeway as far as the Code goes on renewing these special permits when nothing has changed, and everything is in order.

Trustee Cheney wanted to ensure that AT&T was still in compliance with the special conditions included in the motion. Village Attorney, Stephen Gaba, explained that the permit is automatically extended for a period up to six months to give the Village Board a chance to review the application and that the permit is still in effect through January 2021 if the Board wanted to have Mr. Rudzinski perform a site inspection.

The Village Board decided to revisit the matter at the first meeting in September pending a report from the Code Enforcement Officer.
