Trustee Cheney stated that it was a good inspection. He said that the DEC is satisfied with what the Village has been doing and that the DEC said that the Village showed improvement over the previous inspection in 2017. Trustee Cheney stated that the Village continues to pay close attention to the requirements of maintaining its infrastructure.

Mayor Newhard thanked Trustee Cheney for the excellent job he does yearly, along with the help of the entire Water Department. Mayor Newhard stated that this report is available through the Clerk's Office.

Trustee Cheney stated how the 'Village of Warwick Water System 2019 Accomplishments and 2020 Plan' will morph into the 2019 Annual Water Quality Report, and that this report was prepared specifically for the inspection that the Orange County Health Department performed.

Mayor Newhard thanked Trustee Cheney for such a great and concise job. He stated that the work really shows what this administration has prioritized in terms of its infrastructure and maintenance of a system that is vital to the community. Trustee Cheney applauded the Village Board.

9. Warwick Commercial Properties - 4 Overlook Zone Change Short EAF

### **Discussion**

1. Local Residency Card Application and Fee.

Trustee Cheney suggested adding a signature line for the Clerk's Office to reflect who from Village Hall reviewed and approved the application. He also suggested additional language be added to the disclaimer and that documents submitted for proof of residency be dated not more than six months prior to the date of the application, as opposed to not less than six months. Village Attorney, Stephen Gaba, will prepare a draft local law and resolution to set a public hearing to amend the Local Residency Card Local Law that was adopted on October 21, 2019 and delay the issuance of permits until the local law has been revised. The Village Board also agreed that the application fee of \$10 be set by Board motion at a future meeting.

2. 15 Elm Street, Warwick Feed and Grain property - proposed zone change.

Mayor Newhard explained to Mr. Irace that the Village Board discussed the petition for a zone change during the work session that took place prior to the Board meeting. He said that the Board discussed the change from LI to CB and whether mixed used was allowable. Mayor Newhard said that from what the Board could see, mixed use was in fact allowed because in CB you are allowed to have second and third floor apartments and you are allowed to have offices, and it is a combination of the two. Village Attorney, Stephen Gaba, explained to Mr. Irace that he will have to submit an application to the Village of Warwick Planning Board and go through SEQR review.

3. 4 Overlook – proposed zone change.

Mr. Singer expressed to the Village Board that he started the process in 2017 asking to change the zone from Residential District to Office Overlay. Village Attorney, Stephen Gaba, explained that two years ago the Village Board said that they would consider introducing a local law for the change if there were six or seven items completed from a checklist. Mr. Gaba asked Mr. Singer to see Village of Warwick Building Inspector, Boris Rudzinski, to ask him to communicate to the Village Board that everything that was agreed on from the checklist has been completed. Mr. Gaba also stated that once that step is complete, the Village Board may adopt a resolution that states that they are willing to go forward with the process. At that point, Mr. Singer should go back to the Planning Board to have them start SEQR review and then if the Planning Board adopts a negative declaration, the Village Board may go forward with a local law.

Mr. Gaba also stated that there was a problem with the Short Form EAF that was submitted to the Village Board because it just looks at the local law, not the project at all. He said that the

EAF must consider both the zoning change and the project(s). Mr. Singer also had some questions regarding how the property has been taxed as a commercial business. Mr. Singer also talked about an amended site plan that he has been working on with Village Engineer, Dave Getz and his engineer, Kirk Rother, to be presented to the Planning Board for 4 Overlook. He stated that the discussion was to have 4 Overlook attached to the other three lots because of cross easements and being that it's owned by the same LLC, which was determined by the Village Engineer.

Stephen Kitar: Stephen Kitar stated that he is a local business owner. He said he did file a complaint regarding the action of a Village employee and believed that the Village Board was in receipt of the complaint. Mayor Newhard confirmed that the Board did receive it and that it was on the last meeting's agenda. Mr. Kitar said it was sent three weeks ago and he expected a response. Village Attorney, Stephen Gaba, said that he did send Mr. Kitar a letter via regular mail and will email the letter to him as well. Mr. Kitar also wanted to know how the affidavit of service was delivered. Mr. Gaba said that it would be a Village Justice Court matter.

### Warwick Lions Club - Donation of a Bench to the Village of Warwick

On behalf of the Warwick Lions Club, Trustee George McManus and Warwick Lions Club Member, Corey Bachman, presented the Village Board with a bench made of recycled plastic. Trustee McManus explained that the Warwick Lions Club has been collecting plastic, the items that can't be recycled in resident's curbside recycling bins such as dry-cleaning bags and plastic bags that wrap around water cases. The Lions Club sends the plastic back to Trex Corporation and for every five hundred pounds of plastic that the Club collects, Trex sends them a park bench. The first bench was donated to the Warwick Valley Community Center and the Warwick Lions Club is donating this second bench to the Village of Warwick. Through a very informal polling on the Lions Facebook page, the preferred location for the bench to be placed is in Memorial Park by the creek so people who are kayaking have a place to sit, enjoy, and relax.
