The regular meeting of the Board of Trustees of the Village of Warwick was held on Monday, December 20, 2021, at 7:30 p.m. in Village Hall, 77 Main Street, Warwick, NY via Zoom Videoconference. Present was: Mayor, Michael J. Newhard, Trustees: Barry Cheney, William Lindberg, Corey Bachman and George McManus. Also, present was Village Clerk Raina Abramson, DPW Supervisor Mike Moser, and Village Attorney, Stephen Gaba. Others present: Dan Griffiths, Dan Hubbell, and Nathan Unger.

The mayor called the meeting to order and led in the Pledge of Allegiance. The Village Clerk held the roll call.

Mayor Newhard stated that tonight the meeting is beginning with a public hearing and asked the Clerk to read the public notice.

There is no physical meeting location, but for the purpose of compliance with the applicable law, the location of the meeting shall be deemed to be conducted at Village Hall, 77 Main St, Warwick, NY 10990.

Mayor Newhard: Thank you, Raina. Have we received any public notice or anybody who would like to speak, or have you received any correspondence?

Raina Abramson: No, I have not.

Mayor Newhard: Dan, would you like to say anything to the Board before we close the public hearing?

Dan Griffiths: No, right now it's just the 3,500 square foot radiology addition and 2,700 square foot O.R. and we've been through what we're doing with the project and unless you guys have specific questions I could answer, I'm good with everything.

Mayor Newhard: Board Members?

Trustee Cheney: Just for clarification, if our attorney could just explain exactly what this special permit will cover. Is it just what is proposed in these two additions, or does it go beyond that?

Stephen Gaba: Should I answer now?

Mayor Newhard: Yes.

Stephen Gaba: So, St. Anthony Hospital obviously has been in the Village for many years, and I believe it predates the requirements of getting a special use permit. They did come back. Dan was it in the 80s or the 90s we got a special permit? In any event, it was limited for three years, and it expired so as things stand right now there is no special use permit for St. Anthony Hospital as it exists. St. Anthony has come in, they want to build these two additional buildings, I believe some minor parking improvements. They've asked initially for a special permit just for those editions but when the record showed that there was no special permit in existence for the rest of the building, they amended the application to include everything that is there plus these additional improvements and that is what the application is for. We have discussed the possibility of expanding the special permit to extend perhaps minor additions so they wouldn't have to come back for a special permit every time, but the SEQRA review that was conducted by the Planning Board only extended to what is there now plus the additional the improvements

they are proposing so you really can't go beyond that in terms of granting the special permit. So, the special permit when approved, if approved will cover everything that is there now, plus the proposed addition but anything else that they might want to put on the lot will have to come back not only for amended site plan but for an amended special permit as well.

Mayor Newhard read the announcement and then stated that the recommendation went out to local businesses, churches, and any place that the Village felt that people congregate. Mayor Newhard said that the notice was also on the Village of Warwick's and Chamber of Commerce's website and Facebook page. Mayor Newhard said that the business community has taken the information seriously and that it's a very difficult time of year, but the business truly understands the relevance of this matter.

2. Village of Warwick Christmas Eve sing-a-long & Apple Eve Event.

Mayor Newhard stated that the Christmas Eve sing-a-long is usually inside the Old School Baptist Meeting House but will take place this year in-person, outside on the front lawn of the Old School Baptist Meeting House at 5 p.m. on December 24, 2021. Mayor Newhard said that on December 31, 2021, at 11:30 p.m. Apple Eve will take place at Railroad Green. This year the event will take place in a much more streamlined fashion with a count down. Mayor Newhard said that people are asked to socially distance themselves, wear masks, and have some fun to bring in the New Year.

Mayor Newhard asked the Village Clerk to allow Dan Hubbell and Nathan Unger enter the Zoom videoconference.

Mayor Newhard stated to Mr. Hubbell and Mr. Unger that the Village Board is about to go forward with the motions but are now in privilege for the floor if they would like to speak to the Board.

Dan Hubbell stated that he is from Whiteman, Osterman, and Hanna, representing the client and wanted to be available to the extent that the Board had any questions with regards to the documents they are asking to be approved this evening and that he was sure Mr. Gaba fully informed the Board on what was before them.

Stephen Gaba stated that he felt it was clearly spelled out in the approval resolution but to just cover it one last time to make sure there is no confusion, Mr. Gaba explained that there are five documents or instruments that are being offered for dedication. The first is a fifty-foot-wide easement over Sheffield Drive. The second is a deed to the easement area. The third is a clearing easement for sight distance at the intersection of Sheffield and Brady Road. The fourth is a Stormwater Facilities Management Easement Agreement. And the fifth is a blanket easement over the Warwick Commons property, that in general is for installation of utilities should the Village need to do that. Mr. Gaba said that what the Board will be doing this evening is accepting the offers of dedication on all of them, accepting dedication, to keep in mind there is difference between the offer of dedication and accepting the document itself, on all of them except for the deed to the roadway. Mr. Gaba said that the deed to the roadway the Board is not going to take until the roadway is completed and understands that there is a bit of work left to be done on the roadway and that the Board is not obligated to take it at all if the Board decides for whatever reason they don't want to. Mr. Gaba stated that the offer of dedication on the road will actually be filed with the County Clerk. The other offers of dedication will not be filed with the County Clerk because the Board is accepting those, the easements, stormwater facilities management agreement, etc., right now and those documents will be ready to be filed with the County Clerk immediately.

Mayor Newhard thanked Mr. Gaba and asked if the Board has any questions for counsel.

That the Village Board hereby accepts dedication of the 50-ft wide general municipal purposes easement over Sheffield Drive; the clearing easement for sight distance area at intersection of Sheffield Drive and Brady Road; the Stormwater Facilities Management and Easement Agreement; and the blanket easement; and

Discussion

Trustee McManus asked why there are outstanding consultant fees.

Stephen Gaba said that he is here this evening and hasn't billed for his time yet and doesn't know if Dave Getz has all of his time in for reviewing the descriptions which just came in fairly recently, they may be billed next month. Stephen Gaba stated that there is an escrow that the applicant has established that those fees will be paid out of.

Trustee McManus stated that the resolution says, 'conditional upon payment of all fees' and that he understands there is an escrow but will say no because there are conditions to it. Trustee McManus said that he doesn't do 'conditional' and when they pay the fees the Board votes. Trustee McManus added that if there are no questions tonight Mr. Gaba can bill the Village and then the applicant can come back next month or next year and get their approvals when the bills are paid.

Stephen Gaba said that he didn't think that would work.

Trustee McManus said that he doesn't think the Board should approve anything where people owe the Village money for what the Village is going to do.

Stephen Gaba explained that he doesn't think that would work because part of the fees they have to pay is the Board's legal fees, nothing else, and on the night the Board votes, there will always be an attorney sitting there advising the Board and the applicant can't possibly pay that yet because it hasn't been billed yet.

Trustee McManus asked if all of the bills from Mr. Gaba were paid except for tonight. Mr. Gaba said he didn't know at this time.

Dan Hubbell said that he wanted to reiterate that his understanding is that there is an escrow that is established and that there are funds in that escrow.

Trustee McManus said he understands that but never has and never will vote something that has conditions to it and when all bills are paid is when he will vote positively but tonight, he is going to vote negatively because the applicant owes the Village money.

Trustee Lindberg asked Trustee Cheney to provide an explanation of this matter.

Trustee Cheney said that owner for the Kennedy apartments, as part of their site plan, has to construct onsite stormwater control facilities and those stormwater control facilities will need required maintenance on an annual and semiannual basis according to the plan or program for that and their underground tanks that hold the water back, and because they connect to the Village's system, the Village wants to make sure they are in operating order so there are requirements for them to have an engineering inspection and in addition to that, do any mitigation or maintenance that is necessary that comes out as a part of that inspection. Trustee Cheney said that the posting of the letter of credit would be something that the Village could draw on should the applicant fail in their duties and responsibilities relative to maintenance of the stormwater system.

Trustee Lindberg asked if there always has to be \$14,000 in the account.

Trustee Cheney said that the \$14,000 stays as an irrevocable letter of credit and unless it's drawn down, would not have to be replenished. If the owner maintains the system in a manner that is satisfactory to the Village, then the Village would never draw on it and the Village would have a system that is functioning in a proper manner so as it protects the Village's system downstream.

Mayor Newhard asked if there were any other questions for Trustee Cheney or for the Village's counsel.

Discussion

Trustee Cheney asked Stephen Gaba to clarify Chapter 90, Section 90-4 under number 9, that deals with smoking and tabaco use and where it's prohibited or banned. Trustee Cheney stated that in the third line it says there is an exception to private property followed by a list of other areas. Trustee Cheney inquired if those other areas are excepted as well.

Stephen Gaba said that it sounded like you can smoke in those areas which shouldn't be.

Trustee Cheney said that he believes the exception applies only to private property and that the sentence just needs to be restructured.

Stephen Gaba suggested that the Village Board table the motion tonight introducing the local law so the language can be modified and that it can be introduced at the December 27, 2021, meeting.

The Village Board further discussed the matter and decided to table the resolution and clarify the language.

Mayor Newhard asked that under skateboard regulations the language stating, 'skateboards may not' be modified since it reads awkwardly. Mayor Newhard said that he was also concerned that under the responsibilities of supervision of parking, 150-7, where parking must be limited to designated only and where parking is prohibited in non-designated parking areas, that there are certain situations such as the carnival and conversations that the Board has had recently where events need to use those undesignated grass areas as overflow parking or necessary parking; therefore, he feels the section needs to be restructured so the Village has the ability to allow that to happen with Board approval.

Stephen Gaba agreed that the language could be added that says, 'unless specifically waived by resolution of the Village Board' or something along those lines.

WHEREAS, St. Anthony Hospital has applied to the Village Planning Board for amended site plan approval for the construction of a 2,700 s.f. building for radiology to replace the two large trailers where they currently conduct MRI's etc. located on Van Duzer Street and construction of a 3,500 s.f. OR building along Maple Avenue and along part of Grand Street, as well as related site improvements; and

WHEREAS, the Planning Board, as lead agency in SEQRA review of the project, has adopted a Negative Declaration; and

St. Anthony Hospital has been on the subject property for many years and is an integral part of the neighborhood and the Village. The proposed additional buildings will enhance the hospital property.
- B. The proposed use and development of the property does not pose any undue hazards to pedestrian and vehicular traffic. The negative declaration under SEQRA confirms the Village Board's finding on this point.
- C. The location and height of buildings and proposed buildings on the property are not of such nature, size, appearance or location that they will hinder or discourage use or development of other properties in the neighborhood or the district. Again, the hospital has been a fixture in the neighborhood and the Village for many years.
- D. The proposed development will not result in a need for additional public facilities or services or create such fiscal burdens upon the Village greater than those which characterize uses permitted by right under applicable zoning.
