Mayor Newhard: I just want to make a couple of comments because there seems to be some confusion about the opting out of the cannabis laws. What the State has determined is that we have to opt in or opt out, or if we want to opt out we have to do that before the end of December. The State has determined that if you do opt out you are allowed to opt in at any time. So that is significant to know and the reasons for that is maybe as regulations become clearer there would be the ability to opt in on a certain level. But that has not come to us from the State, frankly we have no guidance from the State at this point, they just created a task force so it's really, I think at the beginning stages trying to figure out how to set that up with dispensaries and or other activities that include marijuana. The other two villages have opted out and the town has allowed dispensaries in certain zones within the town. In the conversation with Supervisor Sweeton, if there is some activity in those zones with dispensaries, there would be a sharing of any revenue that would come from the taxes of that, so that I think was a generous offer on his part I wanted to say that to make it a bit more of a public record, but I think that is the spirit. The big difference I believe is zoning, in that the town has a bit more pinpoint zoning in various areas, where for example the Village has one or two commercial zones and they're very broad, they stretch from one end of the village to the other and that would probably give a free ride to someone who wants to set up some kind of facility, where maybe that shouldn't happen. And so, I think we really have to examine and hear from the State, and then, if at some point down the line if opting in makes sense then this Board or another Board can do that.

William Lindberg: What zones have they determined the town?

Mayor Newhard: It is, for example, near Price Chopper that specific area, I don't know what the name of that zone is.

William Lindberg: Ok.

Mayor Newhard: George, what is the response from the Coalition?

George McManus: They would totally be opposed to any in use facilities or sale facilities.

Mayor Newhard: I think our local police also have concerns and mostly because there's too many unknowns as this point. Without that level of regulation then you don't have the ability to monitor or to watch over something. Corey, do you have any questions? I know you've been speaking with the young man who's interested in this.

Corey Bachman: I just want to know if there was going to be any speakers tonight about the issue, but my main concern was if we do vote to opt out can we, once we know more, look at and review opting in.

Barry Cheney: I think you did a good job summarizing what's in front of us I think, I agree with you completely. I mean currently there are no regulations. We have no idea how things are going to work and I think the regulations would play a big part in us determining if and where we would like either of these types of facilities to be allowed in the Village. I think the prudent way to go about it at this point is to precede with the opt out, and if in the future once we know a little bit more and we've seen it in operation in the state, then it can be revisited. If we opt in at this point there's no opting out in the future.

Mayor Newhard: No, and the reason for that and to help people understand that is that once you opt in people will start developing plans which would include financial plans, financial activity. So it's going to be difficult if you suddenly pull the rug out from somebody who is then figuring out, has backers, is developing some kind of facility which would be very expensive, I imagine, so that's basic reason for that.

William Lindberg: Makes sense.

Final Comments from the Board

Mayor Newhard said he heard recently from NYS DOT and that a major pavement project was planned for Route 94, including downtown areas of the Village of Warwick and the Village of Florida. Mayor Newhard explained that this project is extensive and will deal with 94 primarily as well as the intersection of County Route 1 and 94. Mayor Newhard stated that this is long-awaited great news. Mayor Newhard said that feedback from the Comprehensive Plan was that there was a lot of information about street and pedestrian safety, as well as intersections that have issues. Mayor Newhard also said that he was able to set up a Zoom meeting with the design team last week, and he and Trustee Cheney participated. Mayor Newhard said that they were able to cover a lot of ground.

Trustee Cheney said they seemed receptive to some of the suggestions being made. Trustee Cheney continued saying improved pedestrian opportunities with crosswalks to the intersection on Colonial Avenue and Main Street were being considered. Trustee Cheney said that the intersection had been brought to their attention and that it had been looked at for some time. Trustee Cheney said that schematic drawings had been done for how that whole intersection, including back Colonial to Forrester Avenue, might work together for an overall improvement to the traffic patterns in that area. Trustee Cheney continued by saying 17A from Oakland Avenue to the village line would also be done. Trustee Cheney said how it should be an easier project, as no downtown area would be involved, however he was unsure if there was any curbing in the area.

Mayor Newhard answered by saying there where some drainage issues in that stretch that he believed would have to be contended with. Mayor Newhard stated how it was exciting news for the residents of the community because frustrations are heard weekly about the conditions of Route 94. Mayor Newhard said how we had been lobbying for years, being a squeaky wheel when possible, and how this is the fruits of that. Mayor Newhard also said he knew that Mayor Harter had also been a squeaky wheel, as he has roads on route 94, especially leaving Florida, that are in rough shape.

Trustee Cheney stated that the supposed plan is for Florida to get done in 2022, and Warwick in 2023.

Trustee Cheney spoke about the LED Street Light Conversion Project, and how the consultant, Real Term Energy, had been selected a while back. Trustee Cheney continued by saying how they were the same firm that provided services to the Town of Warwick and the Village of Florida for their streetlight conversion. Trustee Cheney said that the contract language was being finalized. Trustee Cheney stated how he was hopeful that it would be signed by the end of the year or beginning of the new year, and then the project could get started.

Trustee Cheney said that the Orange County Health Department is going to do its annual water system review inspection on Monday, December 13th. Trustee Cheney continued by saying he expected to be able to provide the Board with a preliminary report at the next meeting. Trustee Cheney also said that at the wastewater treatment plant, the UV disinfection system, there were some problems with the concrete failure and in UV lamp channels, which required the contractor to redo the work to correct that. Trustee Cheney said the work was accomplished about two or three weeks ago and it seemed the project was ready to be buttoned up.

Mayor Newhard thanked the Board members and asked if anyone else had any comments. Mayor Newhard said they will move forward with an Executive Session.
