Discussion

Trustee McManus inquired where the public hearing is being held. Mayor Newhard stated that the public hearing is being held at Town Hall. Trustee McManus inquired if it should state that information in the motion. Village Clerk, Raina Abramson, stated that Village Attorney, Stephen Gaba, prepared the resolution and said that all of the information would be stated in the legal notice upon posting.

Trustee McManus also inquired if this was only to annex the piece of property, they need to go from twenty-eight homes to forty-five homes, the little .6 acre piece. Trustee Cheney stated that it's a small sliver on the eastern end of the property down by Woodside Drive that is needed to provide for the roadway that goes in from Woodside. Trustee McManus stated, which is only needed if they get approval to build more homes than the twenty acres allows under the current approval. Trustee Cheney stated that he wasn't sure whether they need it or not for the current

approval. Trustee McManus stated that they don't need it for the current approval, so they need to annex .6 acres into the village is if their plan to go from twenty-eight to forty-five is the approved plan. Mayor Newhard stated that that was not how it was described to him and that in essence it is a very small parcel and that it was to clean up the map because there was just a small triangle within the overall development, and it would make more sense. Mayor Newhard said that he thinks that they would pursue this whether they do twenty-eight or they do the larger scale cluster.

Mayor Newhard also included that her family was the Warwick family and she really had an open-door policy, and her house was just that kind of place and she had many young folks that grew up with her family that were a part of the Pius School, which is now the Broderhalf, so she gave refuge to a lot of people. Mayor Newhard said that her work with the food pantry is really an important piece, in that she was tireless, she organized the ongoing food pantry that serves so many people as well as very large activities that were the Thanksgiving baskets and the Christmas baskets and that was a major scale operation that Michele did with a spirit and a rich soul and a big generous heart. Mayor Newhard said that we truly miss Michele and that she was great friends with his mom in that they had a great connection, and he can hear them both laughing in his kitchen, and that we lost a really great person.
