Discussion

Trustee Cheney: It said that it doesn't include anyone under eighteen, but we hire recreation staff under eighteen. Is that because they don't have drivers licenses if they're under eighteen?

Raina Abramson: Are you allowed to do a background check on folks under eighteen?

Stephen Gaba: I don't think you are.

Raina Abramson: That was my understanding.

Trustee McManus: But they're working with youth.

Trustee Patterson: Isn't that something that came up with the auditor?

Stephen Gaba: I know but if the minor has any criminal record it's going to be sealed anyway. Maybe you could do it, but you can't find out anything because their record is sealed. I'll look further into it if you want, but my initial reaction is I don't think you can background check minors.

Trustee Patterson: I think that was an issue that came up when the state comptroller's office was here.

Raina Abramson: Not to my knowledge about employees under the age of eighteen.

Trustee Patterson: No, no just the fact that we need to do background checks on those who work with the camp, with the kids. So, I would like to suggest if we can't do a background check on anybody under eighteen that we don't hire anybody under eighteen because these people are working with children.

Stephen Gaba: But every municipality hires summer counselors who are under eighteen. You see it all the time at summer camps. So maybe there is some way. It can't be that hard. Let me make a couple of calls and I will get back to you as quick as I can.

Trustee Patterson: Ok, great.

Trustee Cheney: And the other question was it wasn't clear. Does it include appointed positions as well, because the appointed can be interacting with each other in Village Hall.

Mayor Newhard: When you say appointed positions...

Trustee Cheney: Planning Board.

Mayor Newhard: All positions.

Trustee Patterson: Volunteering.

Stephen Gaba: Well, yes, why wouldn't it.

Trustee Cheney: I didn't see where it clearly said that. I'm not sure whether it was contradictory or not.

Mayor Newhard: Well, why don't we just put this on hold and take a closer look at it.

Trustee Cheney: It says any adult staff member so if we changed it to employees or volunteer board members?

Trustee Patterson: Appointed positions covers it.

Stephen Gaba: Yes, a volunteer board is appointed because you get appointed if you're a volunteer.

Mayor Newhard: Ok, so you're going to look into this for us?

Stephen Gaba: Yes, I will look into it.

Mayor Newhard: Ok, so we will table that.

Resolution Revising Village Employee Handbook

WHEREAS, it is appropriate for the Village Board to periodically review and revise the Employee Handbook of the Village of Warwick to update the policies and procedures set forth therein in order to better serve the needs of Village, its employees and the community; and

WHEREAS the Village Board has before it a proposal to make certain revisions to the Employee Handbook; and

WHEREAS, the Village Board has reviewed and considered the said revisions, and finds them to be necessary and proper at this time;

NOW, THEREFORE, BE IT RESOLVED as follows:

1. That Section 2.0, "Employee Classifications" of the Employee Handbook of the Village of Warwick including all subparts of Section 2.0, is hereby deleted in its entirety and replaced with the attached revised text.

2. That Section 3.5 of the Employee Handbook, "Behavior Policy", is hereby amended to add a new item (v) to Subparagraph (v) reading as follows:

"Attendance Policy Violations – The following actions will be cause for disciplinary action and/or discharge from employment:

- 1. Excessive absenteeism;
- 2. Excessive tardiness;
- 3. Unauthorized absences and/or failure to give proper notice.
- (vi) An employee who, after investigation, is found to have refused to work additional hours as directed will be subject to appropriate disciplinary action."

3. That Section 4.1 of the Employee Handbook of the Village of Warwick is hereby deleted in its entirety and replaced with the attached revised text.

4. That Section 6.3 of the Employee Handbook of the Village of Warwick is hereby deleted in its entirety and replaced with the following text:

"6.3 Compensation Rates.

(a) Except as provided by a collective bargaining agreement, the compensation rate for Village employees shall be set by the Village Board. Salary increases shall generally be accorded by the Board, in its discretion, and the Village's FY Budget. Such compensation shall be paid on the following basis:

(i) Hourly Compensation Positions:

(b) Longevity pay: In additional to the regular salaries for full time and office employees, the following schedule of longevity pay shall be in effect to be determined as of the employee's anniversary date. Longevity pay shall be paid in a flat amount in accordance with the following formula:

After five (5) complete years of service	\$280.00
After ten (10) complete years of service	\$560.00
After fifteen (15) complete years of service	\$840.00
After twenty (20) complete years of service	\$1,120.00

Longevity pay is not added to wages for the purpose of calculating yearly increases.

Trustee Cheney: Relative to Section 4.1 travel relative to conferences and overtime.

Trustee Patterson: So, it's number three in this resolution. T That Section 4.1 of the Employee Handbook of the Village of Warwick is hereby deleted in its entirety. Is that what you mean?

Stephen Gaba: The revised text is what he is talking about.

Trustee Cheney: I'm talking about the revised text. So, on page five what we have for Section 4 where it says 'Travel' that we strike the preamble to that "In accordance with the U.S. Department of Labor Wage and Hour Division and the NYS Conference of Mayors" and then 'travel during regular workday, that stays the same. Travel outside of the regular workday would read 'time spent by an employee in approved travel outside of their normal workday is, strike the not, considered worktime and will, strike the next not, be counted as time worked. Then in 'Travel Away from Home Community' it should be revised to read 'Travel that keeps an employee away from home overnight is travel away from home. Approved travel away from home is considered worktime. And then strike from when it occurs all the way to the end of the hours of 8:30 a.m. to 4:00 p.m. And then travel, instead of 'it' replace that with travel, must be pre-approved by the Mayor and Village Board. And the rest of it...

Trustee Patterson: Ok, so what you're saying is they will be paid for travel time even if it is beyond the hours of their workday, their typical workday hours.

Trustee Cheney: Right.

Trustee Patterson: Ok.

Trustee Cheney: And even if it's on a Sunday it doesn't have to be within the structure of their normal workday. It can be anytime. My feeling is, if we're sending somebody to a conference or training session, it's for not only the benefit of the individual but the general benefit of the Village itself so I feel as an employer that if it's incumbent upon us to pay for that time.

Trustee Lindberg: If they are being paid by the hour.

Trustee Cheney: Right.

Trustee Lindberg: Right.

Trustee Patterson: Right.

Stephen Gaba: The only thing I would say Barry if you want to do that, and that's fine as far as you're not required to but you can if you want to, are you going to be added this as hours worked or are you just going to be paying this as a stipend.

Trustee Cheney: Hours worked.

Stephen Gaba: Right, so they're going to get overtime.

Trustee Patterson: They're going to get overtime if they hit forty hours that week.

Stephen Gaba: I understand. So, if you send them up to Buffalo, they're going to get an awful lot of hours.

Trustee Cheney: Yes.

Trustee Patterson: Yes.

Stephen Gaba: That's just the way, ok. As long as you're aware, that's fine.

Mayor Newhard: We recognize that it really isn't that many times and that for example our Public Works Department, if they do travel, they automatically get a stipend or a three-hour overtime by their contract, which is fine, that's great – we understand that, but it just seemed that it should be fair if we...

Stephen Gaba: You want it to match up. Ok, as long as you're aware.

Trustee Cheney: And then I did have just some clean up things on 3.5 Behavior Policy. On page three I think Mr. Gaba's intention was that section v the time and attendance violations, that those small roman numerals be changed to numeric numbers, 1,2,3,4,5 so there wasn't any confusion.

Raina Abramson: Ok, I thought it was just the excessive absenteeism 1, 2, and 3 so I'm sorry if that was my mistake.

Trustee Patterson: No, the numbers would be...

Trustee Cheney: So, then that would have to be a, b, and c.

Raina Abramson: Correct.

Trustee Patterson: Lower case a, b, and c.

Raina Abramson: Yes, ok.

Mayor Newhard's Report:

I just have one quick statement to make and this about the AIM funding. We've spoken about this publicly. There have been articles in the paper. The Governor actually came back. There is something called a thirty-day amendment and he has actually reinstated it, but it has bells and whistles which I'm just going to read you the statement from the New York Council of Mayors Executive Director, Peter Baynes:

"While we appreciate the fact that the Governor has acknowledged that the elimination of AIM funding would have serious implications for the State's villages and towns, his "restoration" of this \$59 million is in reality a robbing of one property taxpayer to pay another. Rather than playing this shell game, New York State should be fulfilling its obligation to increase its investment in municipal aid and the property tax relief it will generate. Imposing a new mandate on counties to make up for the state's cut to villages and towns will only further harm New York's already overburdened taxpayers."

And basically, what the Governor is proposing is that it would require counties rather than the state to fund the AIM program through their portion of the sales tax revenue and further calls for freezing the AIM funds at current levels in perpetuity.

AJ Arias: Just because I had a feeling that what you were talking about...I want to be sure I characterize it correctly.

Trustee Patterson: So it's going to be a committee formed by the Mayor with the Building Inspector, the Village Engineer, the applicant, the applicant's engineer and the applicant's landscape architect to come up with a plan that will be guided by the original site plan as approved by the Planning Board to make sure that the buffer that was understood is in fact there.

Stephen Gaba: Well, to make sure that the letter and spirit of the site plan are complied with.

Mayor Newhard: The word I was looking for was field change. I mean it is in essence that.

Stephen Gaba: Well, yes. The Building Inspector can approve a field change, but I think that there is a little more at issue here. There's a claim that they've exceeded, if not what's written in there, is their clearing limit, what was understood to be their clearing limit, and that's, I think, why they're willing to do things to clear this up. So, what's going to happen is they're going to say alright, maybe we have to do this, maybe we don't but we don't want to have a fight over it. Here's what we're willing to do. And then Dave Getz and Boris are going to look at that and say well alright, but I think we need to have this, that and the other thing in addition and then you at least in the first instance will look at that and say well, maybe that's enough, maybe it isn't but how about this and maybe you go back one more round and eventually you come up with something that everybody's, at least a tentative plan, reasonably happy with and then you present it to the whole Board and to the public and then you accept comments on it and then you go back with them and Dave Getz and Boris and you try to come up with a final one which this Board would approve by resolution and that's how you tie up the issue of whether there is going to be an action to prosecute them for violation of their site plan or not. Because you would have to agree that whatever you come up with is going to be satisfactory and you're not going to go after him as long as they stay within those bounds.

AJ Arias: Now, all of this happens during regular meetings, right? Well, not the committee meetings but going back, going to the Board and it's not technically a public hearing but...
