#### **Discussion**

Mayor Newhard said that the shared cost of the banner brackets were not part of this motion tonight, and that that is a separate issue and can be its own motion at a later date.

Trustee Cheney wanted clarification from DPW Supervisor, Mike Moser, for how much time it would take for DPW to attach the brackets and install the banners. Mr. Moser answered by saying the first year would take the most time due to the initial installation of the brackets, but it was not a complicated process.
