The Regular Meeting of the Board of Trustees of the Village of Warwick was held on Monday, January 19, 2021 at 7:30 p.m. in Village Hall, 77 Main Street, Warwick, NY via Zoom Videoconference. Also, present was Village Clerk, Raina Abramson and Village Attorney, Stephen Gaba. DPW Supervisor, Mike Moser was absent. Others present via Zoom Videoconference: Carla Castillo. Mayor Newhard stated that Adam Powers and a staff member from Fizzy Lifting removed the graffiti that day and the DPW staff painted over it completely. After conversations with the Chief of Police and Lieutenant Radar it was decided the idea of having extra patrols over the next three days would be the right thing.

## Police Report - Suspended to Streamline Meeting due to COVID-19

#### **Presentation**

1. Carla Castillo from Hudson Valley Regional Council on converting the Village of Warwick streetlights to LED technology.

Carla Castillo provided a background on the Hudson Valley Regional Council, explained the streetlighting cost analysis and comparison of the benefits of the conversion of streetlights to LEDs through the municipal ownership model versus the utility ownership model, provided a review of the light pollution issues, how to choose the right lights for the village, and concluded with the next steps and some background information. Ms. Castillo recommended that village first obtain a conceptual cost estimate from both Real Term and NYBA for maintenance. Then, consider conducting a basic field audit to get a sense of the condition of the streetlights that are in the village through spot checks. Next, conduct a billing audit that would be managed by a billing audit company that reviews bills from the past six years to find cost savings or on a rare case, they may discover that the village was being undercharged. Once the search has been completed with the conversion company, it is recommended to review the tariff for service classification six to understand all of the different scenarios under which the village may incur certain charges per the tariff. Ms. Castillo can then assist the village by plugging in the conceptual cost estimate from the lighting conversion company into a spreadsheet to determine the cashflow over the course of a twenty-year period so the village can understand the full benefit of converting through the municipal ownership model, which would be the decision point for the village. Ms. Castillo stated that this is where the village can determine, given the program offerings from NYBA, Real Term, or another company, if it is worthwhile.

## **Discussion**

1. Stanley-Deming Park

Mayor Newhard stated that the village received one request to reopen the playground equipment at Stanley-Deming Park. Mayor Newhard stated that when the park was open, the playground was getting sanitized every morning with a vapor driven sanitizer which may be difficult to do with the cold weather. The Village Board agreed to keep the playground closed for the time being due to COVID-19 and once it is decided to reopen the park, possibly have a monitor to control the intensity of use.

Trustee Lindberg discussed the concern of mask wearing at the basketball court and skatepark. Trustee McManus stated that he doesn't understand why the village wouldn't close the basketball court and skatepark if they closed one park because people weren't wearing masks and it was overcrowded, and people are still using the basketball court and skatepark and they're not wearing masks, the village should do the same thing. Trustee McManus stated that the village is responsible, as officials, as much as they can to help stop the spread of the disease and they are allowing the park to be open where people are not wearing masks. Much discussion ensued.

## **Skatepark and Basketball Courts**
