Thomas Scot:

Mr. Scot brought up a traffic study that the Village of Warwick was conducting and wanted to know if there would be a report regarding the findings and decisions of speeding.

Mayor Newhard and Trustee McKnight clarified that there was not a traffic study done, but there were radars set up around the Village to capture speed.

Trustee McKnight explained that the data was being used to let the Warwick Police Department know where they could be most helpful. Trustee McKnight stated most people know where speeding takes place, but that it was better with a data-driven approach. Trustee McKnight stated that he was collecting statics and there were other locations he would like to put the radar, but unfortunately the Village only had one, as they were expensive.

Trustee Foster asked if the report that was sent to the Warwick Police Department could be published.

Trustee McKnight said that with a bit of explanation it could be, and that it would most likely be published on the Village's website.

Mr. Scot suggested publishing the report in the locals papers.

The Board discussed and agreed that putting the information in several outlets was a good idea.

> Mr. Scot asked if the Board had looked at the study at the intersection of Memorial Park and Forester where the crosswalk was located. Mr. Scot was concerned that cars do not stop for the crosswalk.

Mayor Newhard replied that the Village had recently put up a pedestrian crossing sign.

Mr. Scot said that the pedestrian crossing sign gets moved due to trucks pulling into Wadeson's and suggested making the crosswalk go straight across the road inline with Forester and then the sign would not be in the way of the trucks.

Reports

Trustee Cheney's Report:

Trustee Cheney spoke about the Veterans' Crisis Line, which could be reached by dialing 988 and pressing 1. Trustee Cheney explained that the service would provide the caller with a confidential chat with an individual.

Trustee Foster's Report:

Trustee Foster reported about the Veterans' Memorial Park Stakeholder Advisory Group would be meeting on January 23rd. Trustee Foster explained there would be potentially reviewing a preliminary draft. Trustee Foster explained that she had received the survey feedback back from the stakeholder advisory group and would be providing the Board the results via email.

Trustee Lindberg's Report:

Trustee Lindberg reported that a first draft for short-term rental program owner operated had been sent to the Board. Trustee Lindberg explained that there would probably be one more meeting before sending it off to the Village attorney, and then onto a public hearing. Trustee Lindberg added that the False Alarm policy was also in the process of being revised.

Trustee McKnight's Report:

Trustee McKnight reported that another camera had been installed at the skatepark and although it was not at optimally positioned, the technology is hooked up and asked the Board to provide input on the angle of the camera and how it can best be positioned. Trustee McKnight stated that there was one more camera he was looking into, but that everything else was working, which was a several months-long process.

Trustee Foster added that Trustee McKnight had it connected to an app.

Mayor Newhard's Report

Mayor Newhard addressed concerns about the chlorine levels in the Village's drinking water. Mayor Newhard said he reached out to, Keith Herbert, from JCO, who operates the Village's water treatment plant. Mayor Newhard explained that recently the drinking water facility located on Water Lane received a delivery of very fresh chlorine, which was unusual for this time of year, this meant that it was very strong. Mayor Newhard continued saying that this combined with the weather getting cooler created an improved raw water quality from the reservoirs, which drove up chlorine residuals and took several days to safely adjust down without risking public safety. Mayor Newhard explained that it couldn't just be cranked down because it would have resulted in having to boil water. The water did have a higher-than-normal chlorine dosage for a few days but was at no time outside the New York State drinking water standards for chlorine residual. Mayor Newhard said these were some of the intricacies of running a water system and supplying safe clean water to residents, sometime there are hiccups, and this definitely was a hiccup.
