Trustee Cheney's Report:

Trustee Cheney explained that the Federal Government opened a website today for households to be able to request and receive COVID at home test kits. Trustee Cheney said the website can be accessed by going to covidtest.gov and believes it is limited to one request per household and residents will get four test kits as part of that request. Trustee Cheney also explained that the County has been strenuously lobbying with the State to get them to establish a State operated test site in Orange County, so residents don't have to travel to Rockland or Ulster to be able to get a test for COVID.

Mayor Newhard mentioned that there was a County sponsored test kit distribution at the former prison site that was very effective. Mayor Newhard applauded Town of Warwick Supervisor, Mike Sweeton, for organizing it. Mayor Newhard added that they gave out a lot of tests and that the public was very appreciative and also believes that there will be additional dates, including one in the Village that may hold at Memorial Park.

- reset the pillars at entrance to First St Parking Lot for lighting
- RR Green display, new Christmas Nativity, Menorah, Santa's Sleigh and holiday decorations taken down
- painted American Flags on picnic tables at pavilion

- made repairs to skatepark equipment, resurfaced with Skate-lite, but due to the weather the halfpipe wasn't moved but will hopefully be done next week.
