Discussion ensued regarding the request from the Warwick Valley Central School District to expand the outdoor classroom located at the Hallowed Ground for the benefit of Park Avenue Elementary School. The Village Board agreed to allow the expansion, subject to revision and the school district providing the Village of Warwick with a certificate of liability.

Discussion

1. Outdoor Dining.

Mayor Newhard explained that this past weekend was the last weekend approved by the NYS DOT for the expanded outdoor dining on Main Street and that the Village has the ability to expand the dates for up to 120 days. Mayor Newhard stated that he reached out to the restaurants and the Warwick Valley Chamber of Commerce who concluded that Sunday was a day they could do without and that they felt that the outdoor dining was very helpful and that the public has embraced it. Mayor Newhard asked the Village Board if they would consider extending the dates pending the approval of the NYS DOT and NYS Liquor Authority.

The Village Board discussed the extension and agreed to close Main Street, Thursday's – Saturday's to the end of August, subject to NYS DOT and NYS Liquor Authority approval, and asked Mayor Newhard to have further discussions with the restaurants located on Railroad Avenue and Spring Street to find out what their specific needs were.

The Village Board also discussed covering the 'Right Turn Only' sign at the intersection of Wheeler Avenue and Main Street only on the evenings of the outdoor dining. Trustee McManus
