Mayor Newhard also asked that if anyone has creative ideas for the summer concert series to please give him a call.

Mayor Newhard also stated that the Village has received reports about some very horrific things being placed on Facebook, comments, and terrible, terrible things in the face of what is happening nationally, it is terrible. Mayor Newhard wanted to reiterate the words that Rabi Shinder after the desecration of the Jewish cemetery two years ago and that was that hate has no home here, hate does not live here.
