The Mayor called the meeting to order and led in the Pledge of Allegiance.

Announcement

Convenience and flat fees are collected by the web service provider, not by the Village of Warwick and are subject to change without notice. You will receive an email confirmation of your payment. The website will not reflect your payment until it is updated the next business day.

From this site you may view and print current tax bills or receipts and five years of tax payment history at the village level. If prior year taxes show unpaid you can check with Orange County to verify payments on delinquent taxes.

Mayor Newhard: It has been, yes, I'm sorry. I think we were cc'ed but it has been sent...

2. Letter from Village of Warwick Planning Board Chairman, George Aulen reestablishing the lead agency status for Village View Estates subdivision and site plan project

Trustee Cheney: Question on that, they're going to be lead agency, do we need to send them a letter since we're going to be an involved agency, right? I don't know the approach they are going to take, but there are more units that are allowed by right.

Mayor Newhard: Right. I would imagine that would be a precautionary step.

Trustee Cheney: Its appropriate...

Trustee Patterson: (Inaudible) for a special permit...

Trustee Cheney: I'm not sure what process they use to do it.

Trustee Patterson: Haven't they been, all along, before us for a special permit?

Trustee Cheney: Yes.

Trustee Patterson: For cluster?

Trustee Cheney: For the clustering, but are they still considering clustering?

Trustee Patterson: I thought they were.

Mayor Newhard: I thought they were.

Trustee Cheney: Ok. Alright. So, then they have to be so, I would think we would want to have the Planning Board as they did the last time, be in charge of the process, the lead agency in charge of the process.

Trustee Patterson: Right that doesn't take away their application to us for the special permit...

Trustee Cheney: Right.

Trustee Patterson: And last time it was done out of order, not that it ever came to completion, but it was done out of order and there was some confusion about that. Because they were waiting for an answer on those cluster fees for us.

Trustee Cheney: But they wouldn't have to do two separate environmental impact statements.

Trustee Patterson: Ok. I hear you.

Trustee Cheney: That's the point, things would be done in conjunction in one with the other.

Trustee Patterson: What about the annexation, would that be included in that same, there is a sliver of land.

Trustee Cheney: Yes, that would be part of it...

Mayor Newhard: And she is bringing that up (inaudible)...

Trustee Cheney: Didn't they decide to not annex that sliver? I thought they took the sliver out and they weren't going to need to annex it with the new configuration.

Trustee Patterson: But we haven't, and again, my thought was that they were before us for a special permit and they showed us their next iteration for the property but not with any particular application. It was just a review for us, so we haven't completed that special permit process, and nor have we been given a solid, it was literally a drawing.

Trustee Cheney: No, we don't have an application.

Trustee Patterson: Right, so my answer to your question which is before us now, is it that one where they're annexing the property from the town or is it the latest iteration where they're potentially taking it out and if so, I think that needs to be clarified with the application or something in writing.

Trustee McManus: Technically neither one is before because there is no application.

Trustee Cheney: There is an application before the Planning Board. There is nothing for the special permit. And all it mentions is, a site plan for a proposed road in the town is contiguous to village property for the purposes of ingress and egress on the village property so there is no mention of any annexation in the notice we have.

Trustee Patterson: Right, my point is, and no offense to our Planning Board Secretary, but there was some confusion last time. So, I guess my request is to have Mr. Dickover get a handle on exactly what is before the Village as a whole and then specifically before the different Boards so that it doesn't go out of order again. There was a reason for it last time, it wasn't lack of information or lack of knowledge but I think that reason has passed us by so we can do it in order this time. But at Barry's base I agree that the environmental...

Trustee Cheney: It would be done coincidentally

Trustee Patterson: Yes.

Trustee Cheney: for all the actions that are necessary and that they would be the lead agency from our point of view.

Trustee Patterson: For that, yes. But I still think we should reach out to Mr. Dickover.

Mayor Newhard: And going back to your original question, whether we would be an interested party, should I speak to Mr. Dickover about that? I mean it seems...

Trustee Cheney: I don't remember how we handle it the last time but definitely things moved forward together.

Mayor Newhard: We also have a letter from Village Engineer. Any other comments on that?

Trustee Cheney: Question on that, I was hoping to see that they said somewhere in that it was completed in accordance with the plans and specifications, substantially in accordance with the plans and specifications that they prepared. So, we might want to...

Mayor Newhard: It didn't really say that.

Trustee McManus: It says it is.

Mayor Newhard: It said that in the letter.

Trustee Patterson: Oh, but I mean, I guess, ok.

Mayor Newhard: But it would be good if it said that.

Trustee Patterson: So why would it say substantially complete Barry? From an engineering, is that just a technical, do they just...

Trustee Cheney: Well no, it's they never refer to the fact that it was their plans and specifications that were used as a basis for it. So, I feel it should make that statement, that it was substantially completed in conformance with the plan and specifications prepared by Play by Design.

Trustee Patterson: So, at this point right now wouldn't we have to have a dedication like we would a road?

Mayor Newhard: We should...

Trustee Patterson: Like a formal dedication.

Trustee Cheney: Well, aren't we accepting a gift?

Mayor Newhard: Right.

Trustee Cheney: Which would be different, I think, than a dedication.

Mayor Newhard: We are at the next meeting; we have a contract that our counsel made that is the acceptance of it as a dedication.

Trustee Patterson: Ok.

Mayor Newhard: It wasn't ready for this meeting; we're covered by insurance.

Trustee Patterson: Yes, that was my next question. If something happens between now and then.

Mayor Newhard: And that is from Hannelore Chambers and basically that's sort of saying, here is a gift. But it's not formal and it's what we will be doing at the next meeting, the formal contractual acceptance.

Discussion

1. Community Choice Aggregation

Mayor Newhard: I don't know if you guys had a chance to look at what is in the package, it's pretty much a simplified version of this program. It's a program that myself, the two other Mayor's, and the Supervisor are looking at almost simultaneously. This has been a push in New York State for a couple of years. This group, Clean Energy, came to us over a year and a half ago and came to myself and Mike Sweeton at that time it was very new, both Mike and I felt we should wait and see where it is going to go. In the meantime, NYSERDA has backed it as well as NYCOM and the Association of Towns. And what Clean Energy is, the provider of this aggregate energy, so what it means is that we as a community would buy our energy together and we would have to go through certain steps as the municipality to put the program in place in which case everyone in the village would be part of the program but they can opt out if they do not want to be part of it, they can very easily opt out, it's a very simple process. The idea of course is to have lower energy costs and if you take a look at the last page and you look at the Village of Warwick in the annual savings for our residents would be \$386,839. It's a two-year term so it would be double that over the two-year period.

Trustee Cheney: That's divided up among a little under 3,000 customers?

Mayor Newhard: That's right.

Trustee Cheney: But it's still a substantial.

Mayor Newhard: It's still substantial, yes.

Trustee Patterson: So, the residents would have the opportunity to opt out not opt in?

Mayor Newhard: Right. So, everyone is opted in initially.

Trustee Patterson: Yeah.

Mayor Newhard: And they would have to opt out if they do not want it.

Trustee Patterson: I am not a fan.

Trustee Cheney: Yeah, I have struggled with that myself.

Mayor Newhard: I know, I know but, I understand exactly.

Trustee Cheney: But the law is the law of course and the way this is set up.

Trustee Patterson: That New York State set it up. It behooves us to do a fair amount of due diligence and make sure people are aware of it.

Trustee Cheney: The other thing I would suggest we do, although I don't believe we are required would be have a public hearing so that...

Trustee Patterson: Yeah, because that always works.

Trustee Cheney: so, the people have the opportunity to come in and say you know, I don't like this about it, I don't like that about it. I believe there is also the opportunity for individual homeowners to select a green energy verses a standard energy. The green energy is going to be naturally a little more expensive.

Trustee Patterson: Right.

Trustee Cheney: But still it should be less than what energy costs are now on the bills.

Trustee Patterson: The provider is still Orange and Rockland...

Trustee Cheney: The distributor of the energy is Orange and Rockland.

Trustee Patterson: Ok, so there is no technical change or mechanical change then, everybody has to make it their own, it's just...

Trustee Cheney: And those costs are going to remain the same, that component of the energy bill will remain the same I believe, utility bill.

Trustee Patterson: I personally gone to a separate supplier, I guess, and in this case, it was a savings and it wasn't complicated at all, but again I opted into it.

Trustee Cheney: Yeah

Trustee Patterson: I can see the logic of it, I just think it's only fair to spend some to look at that.

Trustee Cheney: By aggregating and saying that I have 2,000 customers for you, this is approximately how much energy I'm going to buy, then the people they buy the energy from say I'll give it to you for this much the next two years.

Trustee Patterson: Absolutely.

Mayor Newhard: Because the other way you would have to go to door to door and say hey. But I believe that the Village of Greenwood Lake is having a public hearing at their next Board meeting and the folks did give a presentation at the town. Barry and I went to that and they also appeared at the...

Trustee Cheney: Associates Towns and Villages.

Mayor Newhard: Associates Towns and Villages for the County. So, they recently just got these numbers and this I think helps their case, it really shows the level of savings that is available.

Trustee Cheney: Has our attorney reviewed the resolution and commented on it?

Mayor Newhard: No, he just gotten it.

Trustee Cheney: How tied this is to the law that is in place, there might not be much flexibility in it.

Mayor Newhard: That was my plan was to send it on his way to ...

Trustee Cheney: And the other thing that I wanted to point out is they are basically going to do a study to tell us how much we can save and then we at some time adopt an agreement with them to do this. I just have trouble understanding why they need us to do this resolution before they do that study.

Trustee Patterson: Because they have to put time and energy into it. I mean they have to know if we are interested in it otherwise why would they bother maybe.

Discussion Prior to Vote

Mayor Newhard: I have a concern, this gentleman has come before us before and I believe in our permit it does say that the, or in the motion, that they have to get approval from the event organizer for street fairs which includes Applefest. Last year this gentleman set up on Main Street and it was pretty mind blowing I had to have him move...

Trustee Cheney: So, he was in the sidewalk, interfering with...

Mayor Newhard: No, he was in a parking spot.

Trustee Patterson: Oh.

Trustee Cheney: Oh.

Trustee Lindberg: Were the cars in it?

Mayor Newhard: Not with his car, with a tent.

Trustee Cheney: Yeah, well, hopefully we made it clear enough to him last year that this year wouldn't be any different.

Mayor Newhard: Yes, I hope so. I thought it was pretty loud and clear.

Trustee Patterson: My concern is that the New York State Gaming Commission has not signed any of these. And it says that the consent forms are verified by the State of New York. There is no signature where it says New York State Gaming Commission.

Trustee McManus: Last year was the first year we allowed them to sell it because we always thought people coming to concerts had to buy a ticket to be there.

Trustee Patterson: Yeah.

Trustee McManus: I think there is a difference between somebody setting up a table off to the side and a person being called up to the front of the stage by the organizer and giving a speech about the raffle.

Mayor Newhard: Yes, it's not a village authorized, it's a separate...

Trustee Cheney: The event you are referring to...

Trustee McManus: Concerts.

Trustee Cheney: Our concerts, well then, we should be able to set the guidelines for how that is handled at our concerts.

Trustee McManus: I like it the way it was prior to last year where we just said no because it gives the impression that concert goers, have to buy tickets, or suggested to buy tickets to attend the concert, that's not true. The concerts are free concerts that are put on by the Village.

Trustee Cheney: Right.

Trustee McManus: Without someone hawking tickets there.

Trustee Cheney: You mentioned allowing to set up a table, was that a suggestion or ...

Trustee McManus: Well, we had in the past by the corner by Caffé A La Mode out of the way but last year since it was approved last year, he was called up to the front to give a speech about the...

Mayor Newhard: He wasn't approved, he was only approved to be able to sell tickets, he wasn't approved to come to our concerts.

Trustee McManus: That should be clarified with the Coordinator.

Mayor Newhard: Concert Coordinator, ok.

Trustee Patterson: Don't you think these should be signed.

Mayor Newhard: Yes, it should be signed.

Trustee McManus: It's not even signed by the Municipal Clerk.

Trustee Patterson: Well, that would be us, wouldn't it? I don't know, I feel like we have the wrong form. Because there is only one spot for the Municipal Clerk to sign, yet all of these municipalities are listed.

Trustee McManus: Well it's supposed to be one form per municipality.

Trustee Cheney: The cover memo, the second paragraph says please approve or deny the proposed raffle ticket sales. And this is to the Municipal Clerk, our raffle drawing and sign the attached form, retain a copy for your records, return a copy to the New York State Gaming

Commission within ten days of the date of this notice and upon receipt by the Commission completed forms will be sent to the organization. So that happens and if we don't get that form then we would have to tell them that it hasn't been approved.

Trustee Patterson: I hear you but I'm just saying the village, the consent forms are verified by the State of New York. I don't ...

Mayor Newhard: But they're after the fact.

Trustee Cheney: After we sign ...

Trustee Patterson: I know the motion says that the village has the raffle consent forms that are verified by the State of New York. So that has to change.

Mayor Newhard: That should be different.

Trustee Cheney: So, we should, instead of that sentence, we should authorize the Clerk to sign the application, the consent for the municipality and return it to the state. I will move to amend the motion to strike the last sentence and add to the motion that the motion authorizes the Village Clerk to sign the form provided and that the applicant will not be allowed to conduct the raffle until such time as the completed form signed by the state is returned to the Village.

Trustee Patterson: What about the part that the Village concerts?

Mayor Newhard: That's our own local ...

Trustee Cheney: That's procedure.

Mayor Newhard: That's procedure, yes.

Trustee Patterson: I would second as amended.

Mayor Newhard: Ok, all in favor.

Trustee Patterson: Cat and Boris. I don't know, I ...
