1. Email from Joan Tirrell

Privilege of the Floor Remarks -Warwick Village Board Meeting

Good evening, Mayor Newhard and Trustees.

Thank you for the opportunity to comment this evening. As a sponsor of the original Black Lives Matter resolution that was submitted to your board by 18 local citizens, I wish express my disappointment that the words "Black Lives Matter" have been removed from the amended resolution that is before you this evening.

I hope that this amended resolution, which I encourage you to adopt with some changes, will symbolize our solidarity to stand against all forms of inequality, most particularly, systemic racism, which continues to impact negatively on our BIPOC community, and was the focus of our original resolution.

It would be deeply meaningful if before adopting this resolution, the Board would consider and approve the following editing changes:

- 1, Please capitalize all references to race, as per rules of grammar, ie: "black and brown" should read "Black and Brown";
- 2. In paragraph #1, please amend the item to read: "...captured the country's attention on the perpetuation of structural racism that continues to negatively impact communities of color;"

(explanation: "racist practices" is anodyne. Yoga is a practice; racism is not. The additional phrase acknowledges the CONTINUING existence of structural racism and is important to the arguments made in the resolution.)

- 3. In paragraph 6, we'd like the beginning of the sentence to be capitalized as such: "we recognize that all Black and Brown Lives Matter..."
- 4. In paragraph 7, please amend the beginning of the sentence to read: "the Village of Warwick, NY recognizes its responsibility to actively oppose all forms of inequality..."

(explanation: This language acknowledges the duty that Village elected leaders have to reject all forms of inequality.

5. Joan Tirrell: Miss Tirrell stated that she believes we all agree that there should be no special treatment for any group of individuals. Joan stated if we looked at LGBTQ individuals, we could say throughout history it has become a very effective movement that has taken hold to assure that treatment is equal. That does not mean that outcomes are equal for all people. Joan stated when it comes to Black Lives Matter, she speaks as a white individual, there are many eloquent and involved black Warwick residents who might not be attending for a variety of reasons this evening. Joan stated, "I too as a white person am Black Lives Matter."

Matter. Joan stated she is among millions of Americans who watch in their lifetime increasing concerns, about systemic injustices. It does not mean people are not good, decent, and kind to others, but it does mean in housing, in banking, and fortunately not everyone but in policing at times. There can be extraordinary ways in which African Americans are treated that disadvantages them.

More discussion ensued about treatment about African Americans.

Joan stated there is a sense of intimidation when a black person speaks up about an issue and feels a great sense of danger and retaliation. These things occur and Joan feels our increasing understanding of how we got here, depending on our skin color each of us has been marked with biases, burdens, and privileges. Joan asked if we would be willing to trade our white skin for black and to receive the same treatment that our black citizens are treated.

Joan stated it is time for us to do what we can and to understand this history. To listen to people of color when they say there are consequences they still pay in prejudice, in racism and we need to acknowledge those problems exist. Joan said we need to take steps to help correct the wrongs and sometimes that is as simple as memorializing a declaration that we believe this. Joan stated Black Lives Matter is not anti-white, it is not radical, it is peaceful, multi-racial and a movement dedicated to equality and justice for all, not equality at the expense of others. Joan said Black Lives Matter should be respected, protected, and uplifted as white lives.

Mayor Newhard stated that when the Village of Warwick received the resolution it was in its original form and did have questions for the Board of Trustees. One of the questions was, where does the Village of Warwick stand as a representative of government for the 7,000 people of the Village of Warwick and considering this is a political movement, why is the Village of Warwick in the position to give it the thumbs up.

Joan stated the solutions to systemic racism lie in public policy and in political activism and that activism does not have to be only marching in the streets. It is finding

understanding and common cause with those especially at the local level who sit in our communities and may be hearing from people in the community about their interactions.

Additional discussion ensued about treatment of African Americans.

Joan stated that she thinks the symbolic resolution acknowledges that systemic racism exists and is a step in the right direction to show compassion and recognition. Joan said it is a symbolic gesture that responds to something that is of deep concern to a significant population that loves Warwick, that has lived here and that is dealing with a lot. Joan stated that they are asking the town that they truly love to hear that and stand together and say your lives matter. Mayor Newhard thanked Joan for attending the Village of Warwick Board Meeting.

The carnival will be open to the public Wednesday, June 23, 2021, through Friday, June 25, 2021, from 6:00 p.m. – 10:00 p.m. and Saturday, June 26, 2021, from 6:00 p.m. – 11:00 p.m. Fireworks are scheduled for Saturday, June 26, 2021, with a rain date of Sunday, June 27, 2021.

In consideration of the COVID-19 Health Emergency, all activities must be in accordance with the Orange County Department of Health, CDC Guidelines and the NYS Department of Health guidance including but not limited to: 'Interim Guidance for Amusement and Water Parks During the COVID-19 Public Health Emergency', 'Advisory for County Fairs and Local Festivals During the COVID-19 Public Health Emergency', and 'Interim Guidance for Food Services During the COVID-19 Public Health Emergency'. Additionally, the following must be adhered to by all employees, event staff, vendors, contractors, and patrons/attendees.

- Capacity Limitations The WFD must ensure that the total number of attendees is limited such that at least six feet of distance can be maintained between individuals who are not members of the same party/household/family.
- Contact Information All attendees prior to arrival or upon entering, must provide their names, address, and phone number for use in potential contact tracing efforts.
- Health Screening Health screenings for all on-site individuals must be performed in accordance with the NYS DOH guidelines prior to entering the carnival.

- Temperature Checks Temperature checks are required upon entry for all onsite individuals. Anyone who presents with a temperature of 100.4 F or greater must be denied entry.
- Face Covering Requirement Masks are required to be worn and must be available for all on-site individuals, including employees, event staff, vendors, contractors, and patrons/attendees. Individuals may temporarily remove their face covering when eating or drinking while seated in a designated area to eat or drink.
- Designated Eating Areas A space must be designated for the consumption of food and/or beverage. All tables with seats must be at least six feet from any other table, seat, patron, or pedestrian thoroughfare.
- Controlled Movement Entrance is limited to two designated areas and must include temperature checks, health screening, and COVID-19 signage consistent with NYS DOH.
- Hand Hygiene Hand sanitizer must be made available throughout the carnival including at entrances, exits, games, attractions, food vendors, and dining areas.
- Cleaning and Disinfection High-traffic areas and frequently touched surfaces must be regularly cleaned and disinfected.
- Communication COVID-19 signage consistent with NYS DOH must be posted throughout the premises including but not limited to, face coverings, social distancing, and hand hygiene.
