The Regular Meeting of the Board of Trustees of the Village of Warwick was held on Monday, March 1, 2021 at 7:30 p.m. in Village Hall, 77 Main Street, Warwick, NY via Zoom Videoconference. Present was: Mayor, Michael J. Newhard, Trustees: Barry Cheney, William Lindberg, Corey Bachman, and George McManus. Also, present was Village Clerk, Raina Abramson. Others present via Zoom Videoconference: Kerry Fenton-Foley and Ron Introini. In consideration of the current COVID-19 health crises and pursuant to Governor Cuomo's Executive Order 202.1 the public was able view the meeting live by going to the Village of Warwick's Facebook page: https://www.facebook.com/VillageofWarwick

The Mayor called the meeting to order and led in the Pledge of Allegiance. The Village Clerk held the roll call.

Mayor Newhard announced the Notice of Continued Public Hearing and asked the clerk to read the notice.

Discussion

1. Village of Warwick Summer Recreation Program.

Mr. Introini introduced himself and stated that he has been the Director of the Warwick Recreation program for over fifteen years. Mr. Introini stated there are over nine summer programs that will hopefully start on June 28, 2021 and go until July 30, 2021 pending Governor Cuomo's Executive Orders, NYS Regional Phased Reopening Plan, and NYS Department of Health. The recreation program will consist of track, swimming, tennis, flag football, soccer, cheerleading, lacrosse, and basketball. The programs are for children ages 5 through 12.

Mr. Introini stated the number one concern is the safety of the children and staff. The nine recreation directors that oversee the programs are certified teachers that have been dealing with children daily and understand the procedures and protocols related to COVID. Mr. Introini stated he has been in contact with community recreation directors to see what they are doing and to gather more information related to COVID restrictions.

Mr. Introini stated the following benefits for having the 2021 summer recreation programs:

- Children need the emotional and social experience.
- All programs will be outside except for swimming.

Mr. Introini created the following safety plan for the programs:

- Participants and staff will complete a daily COVID screening form.
- Participants and staff will have daily temperature checks.
- Daily attendance and who is with what counselor will be recorded for contact tracing purposes.
- Screening forms, temperature checks and attendance records will be kept in binders for contact tracing purposes.
- Lower the registration numbers.
- Equipment will be cleaned at the beginning and end of each session.

The Stanley Deming park program will run between 9:00 a.m. to 2:00 p.m. Approximately 200 to 300 children registered for the park program in previous years, but this year registration will be limited to 150 children for safety reasons.

Participants will register online so the Village will know who is signed up and how old the children are. In previous years children could choose what they would like to participate in but this year children will need to go into groups of 10 to 15 per group with two counselors and there will be a rotation of schedules based on age and activities.

Mr. Introini stated he would like the following items in place for the recreation program:

- Close the park from 8:30 a.m. to 2:30 p.m. to the public on days the recreation program is running for cleaning and safety purposes.
- Have one entrance by the stream/pavilion area to set up daily registration, temperature checks, and collect COVID screening forms daily.
- Bathrooms will be monitored by staff members to ensure there are not too many children in the bathroom at the same time and the bathrooms are cleaned and ready for the next person.
- Water fountains will be turned off.
- Lunch time will be spaced out and children will socially distance.
- Masks will be worn.
- Signs will be placed outside the park indicating closing times for the public.
- There will be a Remind App for parents to monitor notifications.

Mr. Introini stated that he will be working with the Orange County Department of Health. The Orange County Health Department estimated the 2021 protocol will be ready by April/May.

Trustee Cheney inquired about the rain policy. Mr. Introini stated that in the past if there was going to be heavy rain the park program would be cancelled and if it rained during the day children would gather under the pavilion. This year if it rains children will need two to three different areas to gather. Trustee Cheney suggested that the Village consider a temporary tent structure to have it available in case other areas are needed if it rains.

Trustee Cheney asked Mr. Introini if he looked at the additional costs relative to PPE, staffing, and other items that will need to be done. Mr. Introini stated more staff will be needed for the program because there will be two counselors per group. Mr. Introini stated that last year the recreation program prepared as if the park was going to open and purchased equipment, so not much is needed for the children this year. Mr. Introini stated that the money used that is normally spent on equipment can be used to purchase PPE supplies.

Trustee Bachman asked about the screening form and stated it mentions the past ten days. He asked where does that number ten come from? Mr. Introini stated that it is based on the Department of Health guidelines and that is what will be followed.

Mayor Newhard stated that the hiring of staff needs to happen soon and the closing of the park during the program is necessary to have a safe environment for the program.

Trustee McManus would like the closure of the park reviewed by our Village council and the Mayor stated he agreed.

Mayor Newhard commended Mr. Introini on all the hard work he has been doing for the Recreation Program.

Mr. Introini stated that if everything goes according to plan the directors and counselors will be trained and well prepared before the first day of the program.

2. Spread the Warmth.

Kerri Fenton-Foley thanked the Board of Trustees for having her and stated that she came up with the Spread the Warmth idea with her children. Ms. Fenton-Foley stated that people are more in need than ever, food pantries are overwhelmed, and there is always a desire to want to help others.

Ms. Fenton-Foley stated that the Spread the Warmth program consists of hanging gloves, mittens, and hats for people in need, so the items are readily available. Ms. Fenton-Foley put this forward to the Pine Island Chamber and the program is currently being used at the Pine Island park. The cold weather accessories are housed in zip lock bags, so they do not get wet, and hung on the fence.

Ms. Fenton-Foley asked if it is a possibility to hang items at Stanley Deming Park with a sign saying, "If your cold please take what you need and if you can help, place new or gently used mittens, gloves, hats, or scarfs in a labeled zip lock bag to help spread the warmth." The sign is written in English and Spanish.

Mayor Newhard stated it is a wonderful idea.

Discussion ensued about places that would be fitting to hang the items, a place that is private but not isolated, so it is not noticed. The Board of Trustee's agreed Stanley Deming Park would be a good place to implement the program.

Trustee Bachman stated it is close to Christ Church which has the blessings box.

Trustee Cheney stated that it would be good to coordinate with the Warwick Food Pantry and have the food pantry place an announcement about Spread the Warmth with the food they are distributing.

3. Village View Annexation.

Mayor Newhard stated that the Public Hearing was closed at a joint Public Hearing with the Town of Warwick on February 25, 2021. The Mayor stated the Town of Warwick is interested in a form of restrictive covenant on the annexed property.

Trustee Cheney stated that it was a good idea to have the restricted covenant on the property that would restrict it from being used for connecting Village utilities to adjoining parcels. Trustee Cheney asked if the Village of Warwick will have to coordinate the restrictive covenant so that both the Village of Warwick and Town of Warwick have the same wording. Trustee Cheney stated that it is something we would have to check with our Village Council. Mayor Newhard agreed that would be appropriate.

Trustee Lindberg stated that the developer said at the meeting that he would agree to the restricted covenant and give the Village something in writing. Trustee Lindberg asked what the Village's legal right is to do that, and if a developer follows all the rules and they are approved, why would the Village insist that the developer puts something in that can hinder development down

the road. Mayor Newhard stated that he does not know if it would hinder development, but that it means the property.

would remain part of the open space of the property. The Mayor stated it is within the Village's right to make the request to any developer as far as land use goes.

Trustee Lindberg asked if the Village of Warwick would wait for something in writing and Mayor Newhard stated, yes. Trustee Cheney stated that it would be part of a resolution to proceed with the annexation.

Mayor Newhard stated that he will reach out to the Village Attorney, Stephen Gaba, and the Town of Warwick Supervisor, Mr. Sweeton to get clarification.

4. Budget Work Session Dates.

5. Wastewater Treatment Plant Funding.

The Mayor stated that the Village of Warwick received a significant EFC grant which is funding a portion of projects including what is being worked on now, the UV System and Orchard Street Pump Station.

Mayor Newhard stated that he and Trustee Cheney met several times with the Village Accountant, Michael Vernieri. The Village of Warwick has not received a final contract from EFC and is not clear what the timing will be to get the contract and funding.

Mayor Newhard stated that in conversations with Mr. Vernieri the Village of Warwick has two million dollars in costs to make sure there are financial resources for. Mayor Newhard said that Mr. Vernieri feels the Village should do a bond anticipation note so the Village will be able to cover the costs and continue with the work as it is.

Trustee Cheney stated that one of the key reasons why the Village of Warwick must move in this direction is that part of the funding resources that the Village can obtain is 0% construction project financing. Trustee Cheney stated that once the contract is in place, the Village will be able to fund all the work up to 12 million dollars with a 0% construction loan from the EFC. At the conclusion of the construction the Village will then go to long-term financing at reduced rates that are available through EFC. Trustee Cheney stated that the Village is in the process now, the application has been submitted and there are some technical engineering documents that need to be provided to EFC. Trustee Cheney stated that a meeting will be scheduled with the EFC to determine the adequacy of the technical documents. The engineers then sign off on the technical aspects and it then goes to the business side to work on the contract. The Village will then have a better idea as to when the financing will be in place to allow the Village to reach into 0% financing.

Mayor Newhard stated this is a strategy to make sure the Village is not exposed to not having the funds. Trustee Cheney stated that if the Village does have to borrow the cost of going through the process with the attorneys to create the bond anticipation note paperwork and any interest payments that the Village pays would be grant fundable under the contract.

Trustee Cheney stated the next step is that the Village will be reaching out to bond council to have them prepare the paperwork.
