# **Discussion**

1. Facility Use Permits & For-Profit Organizations.

Mayor Newhard stated during the early days of COVID the Village allowed private groups and businesses to use our parks with the understanding that their businesses were severely impacted by COVID. Now that things are opening a bit the Mayor stated that he feels the Board of Trustees needs to consider if the Village should charge a fee for park usage. The Village Code currently states the fee for businesses that charge admission to an event is \$60.00. The code does not state if the fee is per day, per hour, or per month. Mayor Newhard stated the code needs to be looked at carefully. The Mayor stated that there are two facility use requests on the agenda tonight, Trish English and Warwick Fit Body Boot Camp, which are for profit organizations.

Mayor Newhard asked our Village Attorney, Stephen Gaba, what a fair and equitable charge would be for a facility use fee. Mr. Gaba stated that there are two ways the Village can go about establishing the fee:

- The first is to keep track of the hours the Village employees are involved and come up with dollar estimates.
- The second more common way is to come up with an estimate as to what expenses the Village will incur. For example, there is grounds keeping, lighting, and amount of time that goes into upkeep of the parks. Mr. Gaba stated that it could be a one-time fee per day or per session.

Much discussion ensued about charging a fee for profit organizations and how the fee should be charged.

Trustee McManus suggested that the Village approve the facility use requests from Trish English and Warwick Fit Body Boot Camp this evening for three months and charge the \$60.00 facility use fee. After the three months, the Village can re-evaluate the situation.

Trustee Lindberg suggested that the \$60.00 fee be charged monthly for Trish English and Warwick Fit Body Boot Camp and more research will be done on what the schedule of fees should be.

Trustee McManus stated more discussion will be had when the motions are read.
