The regular bi-monthly meeting of the Board of Trustees of the Village of Warwick was held on Monday, March 16, 2020 at 7:30 p.m. in Village Hall, 77 Main Street, Warwick, NY. Present were: Mayor, Michael J. Newhard, Trustees: Barry Cheney, William Lindberg, Eileen Patterson and George McManus. Also, present were: Village Attorney, Stephen Gaba, Village Deputy Clerk, Maryann Benedict and DPW Supervisor, Mike Moser. Approximately 8 people were in attendance.

The Mayor called the meeting to order and led in the Pledge of Allegiance. The Deputy Clerk held the roll call.

A United Effort

We have all been making personal decisions over the last weeks on how to deal with the threats of COVID-19. On a municipal level, we take our directives from Orange County Government, Orange County Department of Health and the Governor's Office. We use two very important information resources, the websites for the Center for Disease Control and Prevention and the Orange County Department of Health. These sites can give you the most up to date information. We are connected to the County DOH by daily conference calls. Each call gives new directives that are immediately implemented. There are still many unknowns, but it is clear we must all do our part.

As new cases are being discovered in our region and testing is underway there are many guidelines that we must follow. In the event you feel you have symptoms it's important to call your doctor, do not go to the doctor's office, emergency room or hospital. Testing facilities are forthcoming, and it will be clear where they are throughout the County through the DOH website.

Personal hand hygiene is the most important thing we can do individually, personal distancing is something that we all should abide by.

As I write this column, we are waiting for a determination from the Governor's Office on a possible delay of this year's Village election. Based on information from OCDOH we have closed Stanley Deming Playground and Basketball Courts and are also anticipating the possible closures of our municipal offices to the public which would include all meetings.
