BOARD OF TRUSTEES VILLAGE OF WARWICK MARCH 26, 2020 SPECIAL MEETING

A Special Meeting of the Board of Trustees of the Village of Warwick was held on Thursday, March 26, 2020 at 10:45 a.m. in Village Hall, 77 Main Street, Warwick, NY. Present was: Mayor, Michael J. Newhard. Trustees: William Lindberg, George McManus and Barry Cheney participated via Zoom Videoconference. Trustee Eileen Patterson was absent. Also, present was: Village Clerk, Raina Abramson. Others present; Warwick Town Supervisor, Michael Sweeton (via Zoom Videoconference) and Kathy Gerstner. Approximately seven people were in attendance.

The Mayor called the meeting to order and led in the Pledge of Allegiance and read the following statement:

In consideration of the current COVID-19 health crises and pursuant to Governor Cuomo's Executive Order 202.1, today's Special Meeting held on March 26, 2020 at 10:45 a.m. will be conducted in the following manner: Members of the Village Board will attend the meeting at Village Hall, 77 Main Street, Warwick, NY or via Zoom Video Conferencing; the public may listen to and view the meeting live at the above date and time on the Village of Warwick's Facebook page.

The Clerk held the roll call.

Mayor Newhard welcomed Town Supervisor, Michael Sweeton, and the Trustees to the meeting. The mayor also announced that today's meeting is a special meeting for a few resolutions that are important to help the public. The resolutions are about amending the Village's penalty assessments so that at this time the Village will not impose penalties for water and sewer utilities.

Motions

RESOLUTION AMENDING SCHEDULE OF FEES

WHEREAS, the Village of Warwick maintains a schedule of fees which includes a

section entitled "Penalty Assessments" which imposes a penalty on utility payments made more

than 30 days after the bill date in the amount of 5% of the total bill on payments received 1 to 30

days after the due date and an additional 3% of the total bill on payments received 31 to 60 or more days after the due date; and

WHEREAS, in consideration of the current health crises and economic hardship caused by the COVID-19 virus, the Village wishes to waive the penalties for late payments of the said utility bills beginning April 1, 2020 and continuing until further action of the Village Board; and

NOW, THEREFORE, BE IT RESOLVED as follows:

1. That effective immediately the Schedule of Fees is amended to suspend the aforesaid provision entitled "Penalty Assessments", and effective April 1, 2020 the penalty imposed under the aforesaid provision for failure to make utility payments within 30 days of the bill date is hereby waived and shall not be imposed again until such time as the Village Board enacts a resolution reinstating the said penalties; and

<u>RESOLUTION TEMPORARILY SUSPENDING THE PRACTICE OF</u> <u>TERMINATION OF WATER SERVICE FOR FAILURE TO PAY UTILITY BILLS</u>

WHEREAS, Village of Warwick Village Code §141-40 provides that if a utility bill for water service remains unpaid for a period of 60 days from the invoice date, water service shall be discontinued until such bill, together with penalties and charges, is paid in full; and

WHEREAS, in consideration of the current health crises and economic hardship caused by the COVID-19 virus, the Village Board wishes to temporarily suspend the practice of termination of water service for failure to pay utility bills when due, including issuance of notices by the Village of potential termination of water service;

NOW, THEREFORE, BE IT RESOLVED as follows:

1. That effective immediately the Village of Warwick shall suspend the practice of termination of water service for failure to pay utility bills when due, including issuance of notices by the Village of potential termination of water service;

2. That the said suspension of the practice of termination of water service for nonpayment to utility bills is temporary, and may be reinstated at any time by further resolution of the Village Board; and

3. The temporary suspension of the practice of termination of water service for failure to pay utility bills shall not in any way signify any suspension or waiver of the obligation to pay utility bills when due.
