# BOARD OF TRUSTEES VILLAGE OF WARWICK MARCH 4, 2019

The regular bi-monthly meeting of the Board of Trustees of the Village of Warwick was held on Monday, March 4, 2019. Present were: Mayor Michael Newhard; Trustees: Barry Cheney, Eileen Patterson, William Lindberg and George McManus. Also, present was Deputy Clerk, Barbara Ranieri. DPW Supervisor, Mike Moser was absent. Also present: Katie Bisaro, Jim Gerstner, Lt. Radar, Patrick Gallagher, Chip Murray, Rich Helt, Alfredo Pacheco, and others.

The Mayor called the meeting to order and lead the Pledge of Allegiance. The Deputy Clerk held the roll call.

### **Approval of Minutes**

A **MOTION** was made by Trustee McManus, seconded by Trustee Cheney and carried to approve the minutes of January 22, 2019 and February 4, 2019. Five Ayes.

## **Approved and Audited Bills**

A **MOTION** was made by Trustee McManus, seconded by Trustee Lindberg and carried to pay all approved and audited bills in the amount of \$234,598.59. Five Ayes.

#### Announcement

Mayor Newhard: Under announcements, the 2019 Village of Warwick Board meetings, there's been a slight change in how we will be meeting each month. The second meeting of each month will begin at 7 p.m. as opposed to 7:30 p.m. That first half hour from 7 to 7:30 will be a half hour work session with our counsel to go over some of the details of the meeting that will then precede it. The public is invited to the work session. We will post all those meetings on our calendar online.

#### Correspondence

Mayor Newhard: Under correspondence we have a letter from Water Supervisor, Chris Bennett, regarding replacing the vehicle meter reading laptop and also a letter from Planning Board Chairman, George Aulen requesting changing the day of the Planning Board meetings from the third Thursday of every month to the second Tuesday of every month effective April 9, 2019.

## Privilege of the Floor

Patrick Gallagher read a letter regarding 16 Elm Street and the residents' displeasure with the procedure; he also brought before and after pictures of buffer trees that were

removed. He stated that there were clear violations. The Mayor responded that at the last meeting when this was brought to the Board's attention that it was determined that the Mayor, the Village Engineer, the landscape architecture for the project would meet and come up with a revised plan that would answer the issues of what had happened there. The Mayor reiterated that he would keep the neighborhood in mind during that meeting. A discussion followed with Chip Murray, Lt. Radar and the Board regarding the Choose Life Parade. A parade route of stepping off on High Street, continuing to Main Street, to Railroad Green was decided on as a shorter route to conserve Police manpower and cost. The Mayor advised Mr. Murray to go back to the Knights of Columbus to see if the parade could be postponed until May 11<sup>th</sup> or May 18<sup>th</sup> to avoid conflict with various other events that are happening the last weekend in April and the first weekend in May. A discussion about municipal ID's took place between the Board and Alfredo Pacheco. Trustee Patterson gave the highlights of a meeting of a Focus Group made up of community leaders of various organizations in the Village such as the Police Department, the hospital, the library, the school district, a local pharmacy and a representative from the merchants' guild and also Jonathan Bix. Each of them were asked if a municipal ID would be something that would help them do their job better with the entire community or any particular population in the community. They all said no, they don't need it. Trustee Patterson said that each of the people who were at that meeting would create a panel which would be open to the public for anybody who has questions about municipal ID's could get answers.

#### **Motions**

#### **Vehicle Meter Reading Laptop**

A **MOTION** was made by Trustee Cheney, seconded by Trustee Patterson and carried to grant permission to Water Supervisor, Chris Bennett to purchase a vehicle meter reading laptop from TCG Solutions in an amount not to exceed \$1,724.99 as per the attached estimate. Five Ayes.

## **Discussion**

Mayor Newhard: What about State bid?

Trustee Cheney: I guess I had a question about whether the computer itself could be purchased under the State bid at a lesser cost than what TCG Solutions is proposing. I believe that this tends to be more critical, this is part of doing our meter readings on a quarterly basis, so eight times a year... I can't remember whether this is an off month or not or whether it could wait but maybe if we could go ahead and approve it and ask that to be looked into. It says not to exceed \$1,700, if we could get them to look at that and possibly get it for less, I think it would be to our benefit.

Trustee Patterson: I agree with Barry.

Trustee Lindberg: Do you want us to just cross out TCG Solutions?

Trustee Cheney: No because their package includes the labor for setting up the laptop, so we'd have to take the whole thing and if we could order it through the State, we could have them either revise their estimate or we buy it directly and then we'd only be paying them \$375.00.

Mayor Newhard: You're going to talk to Chris about that then.

Trustee Cheney: I guess somebody is going to have to check out State bid to see if it's on State bid and then talk to TCG Solutions.

Trustee Patterson: So, we would table this?

Trustee Cheney: No because we're just approving an amount not to exceed so if we could do it for less, we can do it for less.

## **Orchard Street Sewage Pump Station**
