Discussion

1. Application to the New York State Liquor Authority for an on-premises liquor license.

Mayor Newhard said that he called the State liquor Authority and mentioned his concerns about the number of liquor licensing establishments in a small area. Mayor Newhard said he found out that in communities with a population of under 20,000, the 500-foot law does not apply, however, if there are concerns about oversaturation, the Board can approve an official letter be sent to the State Liquor Authority, and that would cause them to examine the application more carefully before making their determination. Mayor Newhard said that there are currently eleven drinking establishments within 500 feet of the addresses application and believed the number would increase.

Trustee McManus stated that as a member of the Prevention Coalition, he thought there were far too many establishments with liquor availability. Trustee McManus said that if there were eleven on Railroad Avenue, that would make another twenty or so in the rest of the Village, and that he would like the new application to be examined closer.

Trustee Bachman asked what some common objections to an establishment like this were. Mayor Newhard answered that objections could be the hours that the establishment is open, but also it could be about the density of the number of restaurants and bars in a vicinity. Mayor Newhard continued by saying that the 500-foot ruling would get looked at by the State Liquor Authority in relation to this application because a concern was brought up, even being under the 20,000-population threshold, that check would come into play.

Mayor Newhard said he spoke to Lieutenant Rader about evening vandalism and there was not a significant amount that occurred in 2020 or 2021, that there will always be some level of vandalism/pranksters, but nothing outstanding. Trustee Cheney said he remembered instances in the past where summer planters were vandalized.

Trustee Cheney said he is also in the Prevention Coalition and understood where Trustee McManus was coming from, but that the main focus of the Coalition was to stop underage drinking. Trustee Cheney continued by saying that The State Liquor Authority has a responsibility and an obligation to be involved in that process whereby checking establishments for improper sale, in most cases, the eleven on the list are restaurants that have combined food and liquor sales. Trustee Cheney stated that he was torn because the Board does not generally get into the business of regulating who can put something somewhere unless it's restricted by zoning, and if it is something that the Board is serious about, then it should be addressed in the zoning. Trustee Cheney expressed his concern over being involved with a process such as this. Trustee Cheney gave a scenario where a business owner goes through the process and gets approval for an intended restaurant by the Village Planning Board, puts in a significant investment into the project, then gets objections by the Village Board when applying for a liquor license, which could hurt the whole project. Trustee Cheney said he thinks there are opportunities to look at it, and he feels better knowing the police department feels there are not pervasive problems in the Village, isolated instances that do exist should be directed at the location where those problems emanate from if it can be determined.

Mayor Newhard read the new motion that was given to him by the Board's council, which differed from the motion on the agenda. Trustee Buchman asked if the Board raised a question toward this application, would the next establishment that applied be automatically investigated due to the number. Mayor Newhard answered by saying that it depended on location, because the number would be based on the address and the 500-foot ruling.

Mayor Newhard agreed with Trustee Cheney in that if this was a concern, then it needed to be addressed in the zoning ordinance, and that it would be a much healthier way then for the Board to be the judge of alcohol. Mayor Newhard expressed that having a concern maybe makes it more appropriate when the Village's zoning is looked at by acknowledging an issue that seems to be growing. Trustee McManus said that it may or may not change the outcome of their application but thinks it's the Boards due diligence to let the State look into it, and maybe by putting a notice on this application that would force the State to pay more attention to the underage drinking problems that are in the Town.

Trustee Cheney asked Mayor Newhard if it was correct that the Board receives these applications/notice forms for everyone applying as well as renewing. Mayor Newhard stated that he believed that the renewal process was not passed along to the municipality, that only new applications were brought before the Board. Trustee Cheney brought up the recent liquor application that the Board chose not to wave the 30-Day period for. Trustee Cheney said that this is something the Board would get each time, and we would have to decide in each particular instance whether or not the State Liquor Authority should look into a particular application. Trustee Cheney stated that he did not know if by sending a letter regarding this application is going to do anything down the road to subsequent applications in terms of the way the State

Liquor Authority look at them unless the Board chooses to send the same letter each time. Trustee McManus agreed with Trustee Cheney and stated that chances of the next one being within 500 feet of those other eleven were pretty slim, and how the street is already locked up. Trustee Cheney responded by saying that the Village had a bank turn into something that required a liquor license, so that if that is an opportunity, then there are other opportunities where store fronts that might not be a restaurant could become a restaurant. Trustee Cheney said he did not think it was going to slow down or change until the needs of the community change in such a way that the restaurants with liquor licenses cannot endure. Trustee Cheney continued by saying that he was not going to object to sending a letter but thinks that there is more work to do if a change is really wanted in the Village of Warwick. Mayor Newhard agreed with Trustee Cheney and said that the method to that is not to do a piecemeal, but to look hard at the zoning ordinances that control this type of activity.

RESOLUTION APPROVING EXTENSION OF COVID-19 HARDSHIP DEFERRED PAYMENT AGREEMENTS FOR MUNICIPAL WATER & SEWER SERVICES

WHEREAS, the COVID-19 pandemic resulted in a state of emergency being declared within the State of New York; and

WHEREAS, one of the state-wide measures taken as a result of the said state of emergency was a moratorium on utility service shutoffs, which included a right for persons who incurred COVID-19 related hardships to enter into deferred payment agreements ("DPAs") regarding any arears on municipal central water and sewer service charges; and

WHEREAS, pursuant to the Guidance received from the New York State Department of Public Service, municipalities are to continue offering COVID-19 related DPAs through June 30, 2022;

WHEREAS, the Village of Warwick has received requests from property owners to enter into DPAs based upon Covid-19 related hardships; and

WHEREAS, the Village has prepared revised forms for DPAs to reflect the said extension which may be utilized for such purposes, copies of which are annexed hereto;

NOW, THEREFORE, BE IT RESOLVED as follows:

- 1. That the Village Board hereby approves the revised DPA forms for use by the Village in Covid-19 related hardship cases;
- 2. That the Village Board hereby authorizes the Mayor to complete and execute such DPAs on any requests for a Covid-19 related hardship DPA that were received by the Village on or before June 30, 2022;
- 3. That any property owner who requests a DPA but fails to return a properly executed copy to the Village Clerk within thirty (30) days after such DPA was mailed or otherwise provided to the property owner shall be deemed to have irrevocably rejected the DPA; and

Discussion

Trustee McManus said that the Board of Trustees is once again providing the time and labor of DPW to a private organization, yes it benefits the park, but it's still a private organization Warwick Skatepark Initiative is not a Village function, it is private, we are again giving DPW time and labor that other people on this board are stretched with outside organization. Mayor Newhard addressed Trustee McManus's concern by saying that he believed that the bulk of the work was going to be done by the Eagle Scout. Trustee McManus said that he believed that, but he wanted to point it out, that they can't be too busy when it's convenient, or when the Board thinks it's convenient.

Final Comments from the Board

Trustee Cheney said that he would like to point out to fellow Board members that the newly installed vertical spiral screen at the Orchard Street Pump Station is functioning as designed by keeping rags and other solids from reaching the Wastewater Treatment Plant, which will be a big help for the operation and other processes that occur there.

Trustee McManus asked Trustee Cheney if the bearing and possible shaft failures of RBCs were new or the old ones. Trustee Cheney responded by saying that they were put in in the 80s, that there are fifteen of them and three have been taken offline due to bearing and shaft problems.

Trustee Cheney continued by saying that over the last five to ten years there have been similar issues on other ones where bearings and in some cases the shaft needed to be replaced. Trustee Cheney said the sooner we get out of this technology and get into the new plant, the better off we're going to be. Trustee McManus asked if the RBCs would all be new at that point. Trustee Cheney said they are going to a new technology. Mayor Newhard interjected by saying that there would be no RBCs at all.
