#### BOARD OF TRUSTEES VILLAGE OF WARWICK MAY 1, 2018

The regular bi-monthly meeting of the Board of Trustees of the Village of Warwick was held on Tuesday, May 1, 2018. Present were: Mayor Michael Newhard; Trustees Eileen Patterson, Barry Cheney, William Lindberg, and George McManus. Also present were Deputy Clerk, Barbara Ranieri and DPW Supervisor, Mike Moser. Also present: Village Accountant, Michael Vernieri, Village Treasurer, Cathy Richards, Katie Bisaro and Cathy Gerstner.

The Mayor called the meeting to order.

The Deputy Clerk held the roll call.

The Public Hearing on a proposed Local Law to Override the Tax Levy Limit was not held.

### <u>Public Hearing on the Tentative Budget of the Village of Warwick for the fiscal year</u> beginning June 1, 2018

Mayor Newhard: We will begin this evening with a public hearing not on the override of the Tax Levy Limit but on the tentative budget of the Village of Warwick for the fiscal year beginning June 1<sup>st</sup>, 2018.

The Deputy Clerk read the public notice.

Mayor Newhard: I would like to ask Michael Vernieri, would you mind speaking to the camera because that's our audience tonight and give a synopsis, a snap shot of this budget and after that I'll give the highlights of what is in the budget as well.

Michael Vernieri: The budget this year is again below the cap. It consists of a shift, however, in monies that were normally taxed in the general fund. They're now being taxed to the sewer and water land tax. In the past budgets, we have talked about sewer and water land tax. It's being used for the improvements of the sewer, the improvements of the water. In the past it's been used to build a microfiltration plant. We have diligently put money aside in order to do these major projects in both water and sewer. In the water we have put money aside for the improvement of the dam, the reservoir and all the related entities that go with that. But for the sewer we have now began a plan to look at the possibility of a new sewer plant. For this particular year we have spent money in our budget or we propose to spend money in the budget for a UV filter and an odor control and in the general fund some of the major items is to buy some new equipment which we sorely need over the years. All of this money is being spent in the general fund for the money we have put away over the years. As far as putting money into a reserve and for the general fund we have put enough money so that all the equipment that is being

purchased by DPW is being paid out of the reserve fund. For the water and sewer, we continue with our bonding and the ability to pay that bonding from the sewer and water land tax. The budget itself is within the cap as I've mentioned, however we have shifted now \$250,000 of tax from the general fund to the water/sewer land tax fund and the purpose of that is to be able to pay for a lot of this new equipment its not \$50,000 or \$100,000 anymore but \$7-800,000 a clip. We're also opening up a reserve for some future sewer improvements and the Mayor will talk about that. That's basically the highlights of what I know about the budget.

Mayor Newhard: Thank you Michael. First of all, I want to thank Michael for your leadership through the budget season because it is not easy. Also, to Cathy Richards for doing that as well. Cathy is the Village Treasurer and it's an incredible job of organization and detail. I'm speaking for the Board, we can't thank you enough for getting that information, gathering that information and then making it presentable to us so we can make those vital decisions. I thank both of you very much. Michael, for your long-term guidance in terms of how we use money the best way and how it will have the least impact on the pocketbooks of our residents but the greatest impact on what we get for those dollars. I'd also want to thank the department heads who are very much part of the process of developing a budget and as well the Board. I'm just going to go over some of the highlights of what's in the budget and these are things that are going to potentially be purchased or done this year. I'll start with the general fund. In Village Hall the plan is to tighten security on the second floor with door replacements and greater security in the Clerk's office as well as three new security cameras for the front door, this conference room and the fire escape which is on the exterior of the building. In the central garage there are many things that are listed but the salt barn is probably the largest and most important and that is to create greater volume, so we can accept larger amounts of salt so that we don't have to be refilling it throughout the year or borrowing it from the Town as a cost. That I think will be very good and help us a great deal. Under streets and roads there's a lot of new equipment and this is what Michael was alluding to. We've been saving our dollars, so we could finance some of these very large pieces of equipment and they include a sweeper, a loader, a bucket truck and one pick up truck. We needed two but one for this year. The bucket truck actually is through a grant that came through Senator Bonacic, so that's actually paid for completely through grant money. The paving schedule for this coming year, which I'm sure everyone wants to hear is West Street, Welling, Campbell, Park, Elm Street and Orchard Street. Michael you've had a rigorous schedule. You did an incredible amount of paving last year and I'm glad to see that you're maintaining that level this year as well. It's important and I know that the residents really appreciate it. Then in parks we are developing a parking lot near the football field and that is also funded partially by a DASNY grant and that's through Senator Bonacic. Also, we are finishing a park renovation by the pavilion which is in Memorial Park as well. That's going to be finished this spring, but we are also going to be working on the walkway that will connect that parking lot at the end of McFarland

Drive by the pavilion to actually the library area. That's a walkway that will allow pedestrians to walk in a very safe walkway instead of on McFarland Drive. This is something we've had in the planning stage for many years and it is going to come to fruition this spring. Also, we will be hiring a consultant this year for a skate park revision and that is very exciting for the skaters in this community. We are one of the first skate parks in the Hudson Valley and our skate park is aging out. We're hoping that in the next few years that we can find the funds to either revamp the skate park that we have or rebuild a new skate park. Under storm sewers and drainage, we'll be working on Wheeler Avenue culvert replacement as well as Country Lane drainage. Under grants we have a host of grants. I mentioned a few of them. Some of them are DASNY grants which are State grants. McFarland Drive parking lot walkway, that's from 2017 and that's being worked on now. In 2019 the Memorial Park parking lot near the football field; the bucket lift truck which I mentioned a little while ago, the HUD grant, CDBG, now we are partnering with Bandwagon Community Center to help them do improvements in their building and also a Justice Court grant for courtroom improvements. Under the water fund we will be seeing a usage rate increase of 2%. Under purification we will be bringing Well #3 online so that includes design and construction of a well that has been offline for a number of years. That is a very important piece that we're excited that's going to happen this year. It will give us redundancy in our water so that if there is a drought then we will have a place to find more water. Under transmission and distribution, water line repairs to Pioneer Farms, that's a main line that has needed some work for some time as well as Barbara Drive, River Street and Campbell Road. In the sewer fund the usage rate and service charges will be increasing this year; 10% increase in the rate and in-service charges the increase will be to equal the water service charges and I don't have that in my notes right here. It will equal the same amount of service charge for both water and sewer. In the activities that are in this budget, the sewer pump station on Orchard Street there's a headworks system that's planned and also a new genset for the Robin Brae pumping station. At the sewer plant we will begin planning for extensive sewer plant upgrades with a \$10,000,000 estimate and I think that's probably the low ball of it. New equipment that we plan to install this year in the sewer plant is UV equipment, the design and installation of that and odor control equipment, the design and installation of that, as well as belt press conveyor replacement and repairs to two of the RBC units. We talked about a new sewer plant; as we are doing that, as we are in the design stages to get to that place, we have to maintain the sewer plant that we have to make sure that it's functioning and that's where those dollars are being spent this year. We just have to create that bridge. Under engineer consultants we will begin studies and design for the new sewer plant upgrades. That is the long story of things that we will see in this next year. I think it's a very assertive budget because I think we are doing a lot and I'm excited about that. What I think I've seen over time is these activities are lead by leadership whether it's in the water department, sewer department and DPW. I can say in all three of those areas we have leadership that is actually doing the work and I'm excited to see and willing to spend the money because I know it's going to be spent for a good

purpose and it will result in a stronger, better water plant or sewer plant or better roads and a better fleet of trucks and equipment. This is really the important part. This is this year's budget and it's fine. It's lovely. We were able to stay under the cap and we were able to do a lot of things, but what is also a part of this year, we've been speaking about a wastewater treatment plant; it is a time for us to reckon with what we need in terms of the future needs of our community. I want to read you a little bit and this is a synopsis, and this is the beginning of wastewater treatment plant 101 that you're going to be hearing all vear long because it's important and it's expensive and we have to figure out how we're going to do this together. The Village's wastewater treatment plant was built in 1972 and it was upgraded in 1992. The cost of building the plant and eventual upgrades were paid through long term bonding. Those bonds were in place when I became Mayor. We were paying off a wastewater treatment plant for what seemed like 100 years. As we were finishing paying it off the whole thing was deteriorating. The plant was originally maintained by Village employees but is now run by a contracted operator. The current operator is JCO Inc. The plant which has run uninterrupted for some 50 years has been showing signs of intense wear and tear. The continual repairs grew yearly to a point where is has become expensive and financially and physically unstainable for the long term. Recently the Village did a preliminary study determining different possible treatment plants including refurbishing the existing plant. The cost of any of the possible options are expensive and for that reason we want to begin a discussion with our residents so that they are fully aware of what we are all facing in the coming year and its economic impact. This year we have begun the important preparation, ground work and engineering to build or rebuild a new plant. We also have begun the process of defining an economic strategy of possible short term and long-term loans and potential grants through the EFC. The EFC is the Environmental Facilities Corporation and it is a New York State public benefits corporation which provides financial and technical assistance to municipalities. It is through the EFC that we actually were able to finance the microfiltration plant a number of years ago. This is the beginning of a multi-year preparation for one of the Villages most expensive and largest planned infrastructure projects. During this year we will be giving you details and information on our progress and how together we will achieve our goal. The Village Board is dedicated to finding the best and most cost-effective solution for a plant that is efficient, environmentally safe, removing the immediate challenges and creating an infrastructure for Warwick's future. That gives you a synopsis of where we're going and you're going to be hearing more about it, but I thank you for listening to that and I appreciate the Board's support as we move forward. Does the Board want to make any comments on the budget for this coming year?

Trustee McManus: I just want to correct the paving is not all of West Street, it's from Pond Hill in. Don't want to scare the people when it doesn't happen. Village of Warwick Board of Trustees May 1, 2018 Page Five

Trustee McManus: But I also think we need something in writing that's they've been to the police.

Mayor Newhard: They were told, and I know that they did... Lisa reached out to the Lt. Radar and made changes in the original to this, but she should have mentioned it and there should be something in writing.
