The regular meeting of the Board of Trustees of the Village of Warwick was held on Monday, November 1, 2021, at 7:30 p.m. in Village Hall, 77 Main Street, Warwick, NY via Zoom Videoconference. Present was: Mayor, Michael J. Newhard, Trustees: Barry Cheney, William Lindberg, Corey Bachman and George McManus. Also, present was Deputy Village Clerk, Jennifer Mante.

### **Announcements**

- 1. On-street parking within the Village of Warwick is prohibited between the hours of 2:00 a.m. and 6:00 a.m. from November 1<sup>st</sup> through April 1<sup>st</sup>.
- 2. The Village of Warwick earned a \$5,000 grant award from the New York State Energy Research and Development Authority (NYSERDA) and was designated as a Clean Energy Community, including an additional \$5,000 grant.

Trustee, Bachman, read the letter from the October 21, 2021 press release that stated the following: The Village of Warwick has been awarded a \$5,000 grant from the New York State Energy Research and Development Authority (NYSERDA) for completing a campaign to promote community solar. Since this was the fourth high-impact action the Village of Warwick completed, the municipality has earned the Clean Energy Community (CEC) designation and an additional \$5,000 grant from NYSERDA. To earn this community solar grant, the Village worked in partnership with Sustainable Warwick on the Triple Win Community Solar campaign. Residents had the opportunity to sign up with a community solar provider affiliated with the campaign, Astral Power or Solstice. Upon enrolling, community solar customers will start saving up to 10% on their monthly electricity bills. In addition, during the Triple Win campaign, residents received a \$100 sign-up bonus as well as the opportunity to select a local nonprofit to receive \$100. "The Village has been working towards its Clean Energy Community designation for several years and it's a wonderful achievement. It clearly defines our goals for sustainability as well as renewable energy resources," said Village of Warwick Mayor Michael Newhard. For the Village to earn the \$5,000 grant for its community solar campaign, it had to sign up a minimum of 10 residents between early June and mid-July. "more then 35 households have signed up through the Triple Win campaign, and that number is still growing," added Michael Helme of Sustainable Warwick. "That means our nonprofit partners -- the Warwick Valley Humane Society, the Town of Warwick Historical Society, Safe Space America, Family Central, the Warwick Valley Community Center, and Grow Local Greenwood Lake – will collectively receive more than \$3,500 in donations from Astral Power and Solstice. The campaign has been good for the environment, good for the residents, and good for the nonprofits – a triple win!" The successful solar campaign was led by Mayor Michael Newhard, Trustee Corey Bachman, and Sustainable Warwick's Michael Helme. Almost all O&R customers who do not have their solar panels are eligible to sign up for community solar, but the sign-up bonuses may get smaller over time. 3. Operation Green Light – an initiative to encourage counties, towns, villages, private businesses, and organizations to light their buildings in green during the week of Veterans' Day (November 7th – 13th) to publicly recognize and thank our veterans for all of their service to our country.

Mayor Newhard said he received a message from American Legion and VFW member, Joe Lawler, who made him aware of Operation Green Light. Mayor Newhard then read the Mayor's Column, dated October 29, 2021, entitled, Shine a Light:

If you go by Village Hall in the evening you will see that it's bathed in green glow. In honor of Veteran's Day November 11<sup>th</sup> individuals, businesses, and government are asked to participate in Operation Green Light. Operation Green Light is a national movement shining a light on the service of our veterans. It is a visual way that we can show our support that is too often not seen by service men and women. Individuals can participate by changing one light on the exterior of their house to a green bulb so that passersby can see it. The attention that it draws will spark a conversation. While the event is focused around the week of Veteran's Day, it is encouraged that individuals continue to shine a light year-round. By shining a green light, you let Veterans know that they are appreciated and supported, especially those who served in Iraq and Afghanistan in the last 20 years. Mayor Newhard thanked the DPW for their creative effort getting the lights to bathe the front of Village Hall.

Mayor Newhard thanked those who participated and said that there were some scary houses and actors because folks really go all out and every year it seemed to get better and scarier. Mayor Newhard continued by saying it's a fun thing to do and it was a perfect blustery night to look at all the decorations. Mayor Newhard said that plaques will be made and Village Hall will give the winners a call when they can be picked up. Mayor Newhard added that the annual Costume Contest was held virtually this year instead of stopping at Village Green, which causes a large crowd to congregate. 1. Mayor Newhard read the following letter from Steven Gross:

Dear Mayor Newhard and Honorable Members of the Board:

I recently filed an appeal to the Zoning Board of Appeals (ZBA) to challenge a Building Permit issued by the Building Inspector for the construction of a 7,570 square-foot house on the referenced property. I did so primarily because I am alarmed, as a general matter, by the circumstances under which construction was allowed to proceed on this property. Among my concerns are the following:

- Site clearing was allowed to commence before the proposed structure had any permits of any kind.
- The property was clear cut in violation of § 131-5 of the Village Code, which restricts the removal of trees.

- The removal of trees violated the conditions of the original ca. 2000 Oak Knolls Subdivision Approval, which required the preservation of a 25-foot buffer of existing trees along the Village/Town boundary on the eastern property line.
- For various reasons, including the property's location at a Village Gateway and adjacent to the Historic District, the fact that it contained wetlands, and that the new site plan bore almost no resemblance to the site plan depicted in the Oak Knolls Subdivision plans, the new site plan required review and approval by the Planning Board (See § 145-90 of the Zoning Code), which was not obtained.
- Wetlands were illegally destroyed and filled during site preparation in violation of the Army Corps of Engineers Permit for the subdivision, which allowed two limited driveway crossings.

My purpose in filing this appeal is to bring to light obvious deficiencies in the operation of the Building Department that led to this situation, and to make sure these deficiencies are rectified not just for this parcel, but more importantly, for all future development on lots in the Village of Warwick. I am not filing an application with the ZBA for my own personal gain or benefit.

Subsequent to filing this appeal, I received a letter from Maureen J. Evans, ZBA Secretary, requesting that I not only submit a check in the amount of \$150 for the application fee, but also a second check for \$2000 to cover an escrow account to pay for the review of my appeal.

In checking the fee schedule for the ZBA, I see nothing for which a \$150 fee would apply. The fee schedule lists just two categories of application fees for the ZBA; a \$200.00 per lot fee for "Residential", and \$100 fee for "Residential review, per dwelling." Any description of these two categories is completely absent, and leaves open the question of whether either applies in this situation, as I am not applying for any variance or approval associated with a residence, but rather an appeal of a decision by the Building Inspector. In any case, there does not appear to be any basis for a \$150 fee. I just had a conversation with Ms. Evans, who has informed me that the fee was assessed for an "interpretation" by the ZBA, but there is no such category or fee listed in the Fee Schedule available online. I'm not even sure that categorization would be correct, as I am not asking for an interpretation of the Village Code, which as I have laid out in the appeal, I believe is quite clear. My appeal is based on the action of the Building Inspector having no basis in the Village Code, and needing to be vacated.

Regarding the escrow amount, § 64-3(D) of the Village Code (Reimbursement of costs and expenses) states:

"With regard to applications to the Zoning Board of Appeals for variances, the Village Board for zone change applications and the Planning Board for subdivisions, conditional use permits, change of use applications, lot line changes and site plan, the respective Board, as the case may be, shall set an amount, in consultation with the Village Engineer, Planner and Attorney,

to be placed in an escrow account to be maintained by the Village for the purpose of paying the fee statements of the Village professionals in connection with the review of the application." (emphasis added)

It appears from this section that an escrow may only be required by the ZBA in connection with an application for a variance, which does not apply in this situation. In consulting with two prominent land use attorneys, I am also being told that municipalities typically do not seek reimbursement in situations where the decision of a Building Inspector is being appealed by a third party resident who is not subject to that decision.

The Village Code also provides in § 64-4 that an "applicant may appeal, in writing, to the Village Board for a reduction in the required reimbursement amount." Accordingly, in consideration of the fact that I am undertaking this appeal to highlight a deficiency in the Building Department, and not for my own personal benefit, and that I am doing so, rather, for the benefit of the Village and all its residents, I am requesting that the Village Board either make a determination that the requested fees and escrow do not apply to this situation, or to waive those fees in accordance with § 64-4.

Mayor Newhard said this was something that will be sent over to the Village Board's counsel. Mayor Newhard stated that as far as a reduction in fees, it is not something that has been done, as it would be considered a level of gifting and state law requires to not do that. Mayor Newhard continued by saying that even though it states that in the Village Code, it's not a good policy to get into for anything. Mayor Newhard said that he will bring this to Village Attorney, Stephen Gaba, and get his thoughts and then respond to Mr. Gross. Trustee Cheney asked if a copy could be provided to the members of the Board. Mayor Newhard responded by saying absolutely, yes. Trustee Cheney thanked Mayor Newhard.
