BOARD OF TRUSTEES VILLAGE OF WARWICK October 5, 2020

The Regular Meeting of the Board of Trustees of the Village of Warwick was held on Monday, October 5, 2020 at 7:30 p.m. in Village Hall, 77 Main Street, Warwick, NY via Zoom Videoconference. Present was: Mayor, Michael J. Newhard, Trustees: Barry Cheney, William Lindberg, Corey Bachman, and George McManus. Also, present was Deputy Clerk, Maryann Benedict and DPW Supervisor, Mike Moser. In consideration of the current COVID-19 health crises and pursuant to Governor Cuomo's Executive Order 202.1 the public was able view the meeting and comment during privilege of the floor at the above date and time via Facebook Live on the Village's FB page https://www.facebook.com/VillageofWarwick.

The Mayor called the meeting to order and led in the Pledge of Allegiance. The Village Clerk held the roll call.

Correspondence

1. Letter from Orange County Department of Public Works regarding Bank Street Bridge.

Mayor Newhard thanked DPW Supervisor, Mike Moser for cleaning up the area around the bridge and making it presentable for pedestrians.

2. Letter of retirement effective December 31, 2020 – Village Treasurer, Cathy Richards.

Mayor Newhard thanked Cathy Richards for her ten years of service to the Village and stated that she has done an extraordinary job.

3. Letter from Law Office of Blustein, Shapiro, Rich & Barone, LLP regarding Village View Estates – Petition for Annexation and Application for Special use Permit.

Mayor Newhard stated the Village Board will not be acting on this letter this evening and that it has been referred to the Village's legal counsel, Stephen Gaba, and will be discussed further in a future work session.

4. Letter from Richard E. Nicholas withdrawing the request to place a memorial sundial at Hallowed Grounds.

Discussion

1. Village Assessor.

Mayor Newhard stated that the Village Board discussed hiring a Village Assessor a couple meetings ago and the Village is now at a point that the Board needs to make a determination whether they advertise for an Assessor or if the Village should go with the Town of Warwick Tax Assessor.

Much discussion ensued about hiring an Assessor and the Board decided to advertise for a Part-Time Assessor.

2. Warwick Grove – Request to store snowplow equipment in the McFarland Drive parking lot.

Much discussion ensued about storing the snowplow equipment in the McFarland Drive parking lot and how spillage from the equipment could contaminate the soil and parking lot. Trustee Lindberg and Trustee McManus stated the Village should not be responsible for storing the equipment, and that the responsibility should fall on Warwick Grove and the Wright Brothers. Trustee Bachman stated he talked with some residents of Warwick Grove and they stated the snowplow equipment should be moved off their parking lot because the fumes from the machinery were going into the condominiums of senior residents and causing health concerns.

Mayor Newhard stated that the Board is split about a decision and there is some time to create a motion. Trustee Cheney stated a motion based on a memorandum agreement should be created and voted on.

Trustee Cheney will reach out to Warwick Grove's Homeowner's Associate to provide some guidelines to create the agreement.

3. Pump Track.

Mayor Newhard stated that Trustee Cheney went to West Milford and took some pictures of their Pump Track to share with the Board of Trustees.

Mike Moser stated that the track could be built with engineering help from Village Engineer, Dave Getz.

Much discussion ensued about where the track should be located.

Mayor Newhard stated that Dave Getz, Trustee Lindberg, Trustee McManus, and Mike Moser should meet and find the best place to put the Pump Track.

Privilege of the Floor

- 1. Mike Maurer, via phone stated that he enjoys Memorial Park. One of the things he is concerned about is that the park is dedicated to active enjoyment (softball, football, skatepark, etc.). He stated that he does not want to see more of the park converted from natural landscaping into a Pump Track.
 - Mr. Maurer stated that there are plenty of sites in the Town of Warwick that are better suited for the application.
 - Mr. Maurer also asked what became of the master plan pertaining to how we are going to develop Memorial Park when these types of projects come up.
- 2. Lugene Maher, via phone asked if the public has access to the development agreement that is referenced in the letter regarding Village View. Mayor Newhard stated that the

development agreement is attorney-client privileged information and is in a draft state. Trustee Cheney stated the agreement will be published to the public prior to the Board acting on it.

Lugene Maher asked if the Board agreed to place striping and one radar speed sign on Locust Street as the solution to the significant concerns raised by the residents relative to safety and traffic. Mayor Newhard stated that is a topic that will be further discussed in a work session. Trustee McManus stated the radar sign is there to gather information. Raymond Maher, via phone asked if the people that live in the area will have input on the solution to the traffic problem. He stated the radar signs are a challenge to people to see how fast they are going, and it is not a solution to the proposed improvements that were supposed to be made to Woodside Dive, Locust Street and Valley View. Mayor Newhard stated that Mr. Maher's comment tonight is part of the record and if there are other comments from residents, please reach out to the Village Board by email or letter.

- 3. Cathy Conroy commented on Facebook about wearing masks at Stanley-Deming Park and asked what the schedule is for the park being disinfected. Mayor Newhard stated the park is disinfected and sprayed every morning including weekends. He stated there are many signs placed around the park enforcing the wearing of masks.
- 4. Barbara Bald, via phone stated that the Pump Track should not be put in Memorial Park She stated there are other areas in the Town of Warwick that would be better suited for it.
- 5. Kerri Fenton Foley stated that on Facebook that she has always been a tremendous supporter of the Village playground being a playground for all. Ms. Foley asked that during this pandemic is there a possibility that it is for Warwick residents only? Mayor Newhard stated that it will be taken into consideration.
- 6. Frank Fornario, via phone asked why the Lions Club did not propose the Pump Track to the Town of Warwick because he felt it is designed more for a town wide use as opposed to just the village. Mayor Newhard stated Barbara Bald expressed the same concept. Mayor Newhard stated the Village has a master plan for Memorial Park that is many years old and its time to look at that and come up with a greater overall masterplan that is new.
- 7. Lissa Scott, via phone stated that she was part of the meetings for the master plan ten years ago. Ms. Scott asked where are the walking trails, exercise stations, and green space that were part of the master plan? Ms. Scott stated she agrees with the other residents about putting the Pump Track in the Town Park and that the master plan should be revisited.

Deputy Village Clerk, Maryann Benedict, stated the following additional items were suggested on the Village's Facebook Page:

- The master plan had consideration for seniors, follow up on the ideas.
- The Pump Track does not belong in Memorial Park, should be considered in one of the Town Parks.
- People are not wearing masks in Stanley-Deming Park.
- Residents outside the Village are coming to Stanley-Deming Park and not wearing masks.
- A Village parks and recreation committee should be formed.
- Trees need to be cut back coming out of Locust Street.
