BOARD OF TRUSTEES VILLAGE OF WARWICK OCTOBER 7, 2024

The Regular Meeting of the Board of Trustees of the Village of Warwick was held on Monday, October 7, 2024, at 7:30 p.m. in Village Hall, 77 Main Street, Warwick, NY. Present was: Mayor, Michael J. Newhard. Trustees, Barry Cheney, Thomas McKnight, and Mary Collura. Also, present was Deputy Village Clerk, Jennifer Mante. Absent was Trustee Carly Foster. Others present, Bob Krahulik, Brian Singer, and Kristina Hoti.

The Mayor called the meeting to order and led in the Pledge of Allegiance. A moment of silence was made for Trustee Foster's father. The Deputy Village Clerk held the roll call.

Acceptance of Minutes

Authorization to Pay all Approved and Audited Claims

Presentations

1. Barton & Loguidice – Wastewater Treatment Plant Progress.

Karen Clark from Barton & Loguidice provided an update on the wastewater treatment plant progress. The discussion included:

- the start date for the project, indicating that work would commence after the bid was awarded. The exact start date was not specified.
- confirmation that no changes were planned for the Orchard Street pump station, as it was in good shape.
- there were no planned SCADA or electrical work changes at the Orchard Street station. The controls at the station would remain as they were.
- that the budget was slightly over the initial estimate, around 15% higher. Ms. Clark suggested updating the budget estimate closer to the bid submission for review.
- the next checkpoint for the project, with Ms. Clark suggesting it should be when the final plans are submitted for review.

Announcements

1. All Things Halloween in the Village of Warwick.

Trustee Collura announced various Halloween events in the Village of Warwick, including a costume parade, the Scare the Mayor Contest, a Halloween house self-guided tour, as well as the Halloween curfew and road closures.

2. Village of Warwick Fall Leaf Pickup.

Trustee Cheney announced that the Village of Warwick will begin picking up leaves on November 1st, with leaves needing to be placed at the curb prior to December 9th for final pickup.

Discussions

1. Schedule of Fees Parking Fines/Violations.

Trustee Cheney discussed the need to update the schedule of fees for parking fines and violations. He noted that parking fines have not been updated in many years and did not reflect the severity of offenses. The new structure aims to address this issue.

Trustee Cheney went into detail regarding the Village's new traffic enforcement system where the Traffic Enforcement Officer will use handheld devices to scan registrations and

issue tickets. This system will streamline the process and improve accuracy. The new system would specify various parking violations that were not previously detailed on tickets as well as take photographs of violations, which will be included on the ticket. This evidence will help in court proceedings and reduce disputes.

A discussion ensued regarding the increased fines for electric vehicles parked in charging spots after charging is complete. The proposed fine is significantly higher than other parking violations to ensure these spots are available for other users. Trustee McKnight believed the suggested fine was too high given the offence.

The Board didn't have any major objections to the proposed changes and Mayor Newhard called for the topic to be on the next agenda.

2. 2024 NY Forward Revitalization Initiative Grant.

Mayor Newhard provided an update on the progress of the New York Forward Revitalization Initiative Grant, including the formation of a task force, community outreach efforts, and collaboration with Millennium Strategies for the grant application.

<u>Public Comment</u> - Agenda Items Only

GUIDELINES FOR PUBLIC COMMENT

The public may speak only during the meeting's Public Comment period and at any other time a majority of the Board allows. Speakers must be recognized by the presiding officer, step to the front of the room/microphone, give their name, residency, and organization, if any. Speakers must limit their remarks to three minutes (this time limit may be changed to accommodate the number of speakers) and may not yield any remaining time they may have to another speaker. Board members may, with the permission of the mayor, interrupt a speaker during their remarks, but only for the purpose of clarification or information. The Village Board is not required to accept or respond to questions from the public at meetings but may request that inquiries be submitted in writing to be responded to at a later date. All remarks must be addressed to the Board as a body and not to individual Board members. Interested parties or their representatives may also address the Board by written communications.

Bob Krahulik provided the Board with an update on the vandalized political sign on Main Street. He also gave his opinion on the parking fee topic the Board had discussed. Mr. Krahulik spoke of an issue with reserved parking spaces in the Chase Bank parking lot where people who paid for a permitted spot would find another car parked in their spot at the end of the day or night. As a result, they would park elsewhere and receive a ticket. It was recommended to add a code provision to forgive such tickets. Village of Warwick Board of Trustees October 7, 2024 Page Four

Mr. Krahulik agreed with the higher fine amount for electric vehicles overstaying at charging stations. Unlike metered spots on Main Street, there are only four charging spots, and electric vehicles need to charge to leave the Village. He shared a personal experience where he saw cars abusing the charging spots by staying all day, and he would publicly shame them on Facebook. He believes a financial incentive is necessary to prevent such abuse.

Switching topics, Bob Krahulik, attorney for property owner, Brian Singer, explained the reasoning behind the zone change request for 4 Overlook Drive and 1 Galloway Heights Road. There was a discussion regarding a house, currently zoned for residential purposes but historically used as professional office space, enjoying a pre-existing non-conforming use. The current zoning does not allow the existing parking lot to be compliant. A zoning change would enable the property to meet the necessary requirements and support economic growth.

Moving on to the requested zone change for 42 Orchard Street, Mr. Krahulik discussed the need to change the zoning classification for a portion of the Warwick car wash property to bring it into compliance. By obtaining a zone change, this would allow the filing of a subdivision map and recording a deed to attach the parcel to the rest of the car wash. Currently, traffic around the back of the building, although covered by a lease agreement with property owner, Vanessa Man, enters the residential district, which is technically a commercial use.

Vacation Carryover - Michael Finelli

WHEREAS, the Village Board finds that the proposed taking is for a public purpose and that the Offer of Settlement constitutes fair and adequate compensation for DOT's acquisition of title to the property at issue.

RESOLUTION ADOPTING THE PRO-HOUSING COMMUNITIES PLEDGE

WHEREAS, the Village of Warwick believes that the lack of housing for New York residents of all ages and income levels negatively impacts the future of New York State's economic growth and community well-being; and

WHEREAS, the Village believes that the housing crisis has negative effects at regional and local levels, and that every community must do its part to contribute to housing growth and benefit from the positive impacts a healthy housing market brings to communities; and

WHEREAS, the Village believes that supporting housing production of all kinds in its community will bring multiple benefits, including increasing housing access and choices for current and future residents, providing integrated accessible housing options that meet the needs of people with sensory and mobility disabilities, bringing economic opportunities and vitality to our communities, and allowing workers at all levels to improve their quality of life through living closer to their employment opportunities; and

WHEREAS, the Village believes that evidence showing that infill development that reduces sprawl and supports walkable communities has significant environmental and public health benefits; and

WHEREAS, the Village believes that affirmatively furthering fair housing and reducing segregation is not only required by law, but is essential for keeping its community strong and vibrant;

NOW, THEREFORE, IT IS HEREBY RESOLVED that the Village of Warwick, in order to take positive steps to alleviate the housing crisis, adopts the Pro-Housing Communities pledge, under which it will endeavor to take the following important steps:

1. Streamline permitting for multifamily housing, affordable housing, accessible housing, accessory dwelling units, and supportive housing;

2. Adopt policies that affirmatively further fair housing;

3. Incorporate regional housing needs into planning decisions;

4. Increase development capacity for residential uses;

5. Enact policies that encourage a broad range of housing development, including multifamily housing, affordable housing, accessible housing, accessory dwelling units, and supportive housing.

Discussion

The Board highlighted the Village's success in providing almost 500 units of affordable senior housing and a diverse mix of housing types that accommodate various income levels. They noted that the Village has a clear path for permitting multifamily housing, with several projects already approved by the Planning Board.

Satisfaction was expressed with past efforts but acknowledged the need for minor adjustments. They also mentioned the state's narrow time frame for evaluating housing efforts, which seemed unfair due to the COVID-19 pandemic. Additionally, the Village's housing percentage is based on downstate numbers because it falls within the Metropolitan Transit Authority circle, adding to the challenges.

Mayor Newhard emphasized the significant work done in providing supportive senior housing and identified young families as the current group in need.

Request for Zone Change – 42 Orchard Street

A **MOTION** was made by Trustee McKnight, seconded by Trustee Collura, and carried to acknowledge receipt of a Petition in connection with a proposed change in zoning classification for a portion of the premises located at 42 Orchard Street in the Village of Warwick, to set an escrow at \$2,000, and refer the Petition to the Village Attorney and Village's Engineering Consultant for review and comment.
