The Regular Meeting of the Board of Trustees of the Village of Warwick was held on Tuesday, September 8, 2020 at 7:30 p.m. in Village Hall, 77 Main Street, Warwick, NY via Zoom Videoconference. Present was: Mayor, Michael J. Newhard, Trustees: Barry Cheney, William Lindberg, Eileen Patterson, and George McManus. Also, present was Deputy Clerk, Maryann Benedict, Village Clerk Raina Abramson, Village Justice Jeanine Wadeson. Others present via Zoom Videoconference: Frank Fornario. Mayor Newhard stated that this letter has been sent to our legal counsel, Stephen Gaba, for comments.

2. Letter from Michael Jay Dombrowski announcing his resignation as an alternate member of the Village of Warwick Planning Board.

Mayor Newhard thanked Mr. Dombrowski and stated he did a great job in a very short window of time. Mayor Newhard announced that the Village of Warwick is seeking members for both the Planning Board and ZBA.

Mayor Newhard stated if anybody is interested in helping and serving their community this is a wonderful way to be involved.

## **Discussion**

1. Village of Warwick Justice Jeanine Wadeson – Propose the hiring of a Prosecutor for Traffic and Parking Matters in the Village of Warwick Court

Judge Wadeson proposed to hire John E. Bach, Esq. of Goshen, N.Y. to act as Village prosecutor to handle traffic and parking tickets in the Village Court.

The Mayor stated that a meeting was held about a month ago with Judge Wadeson and the Court Clerk to discuss the reopening of the Village Court. Mayor Newhard stated that there is an issue about the processing of certain tickets regarding consistency and health related matters during COVID-19. Mayor Newhard explained that in the past, officers and the public used the upstairs office space in Village Hall as an area of privacy, explaining how this is no longer where we can put multiple people during the COVID-19 health crises.

Much discussion ensued about how the court should handle tickets and hiring a prosecutor.

The Village Board stated that additional candidates should be considered and Mayor Newhard would like to reach out to the Village Attorney to discuss issues surrounding this matter.

2. Warwick Grove – Request to store snowplow equipment in the McFarland Drive parking lot.

Discussion ensued about the possibility of allowing Warwick Grove to store the equipment on Village property including the necessity to have a hold harmless agreement, proper insurance and a nominal fee being charged for the use of the Village parking lot.

The Village Board stated that they will consult with the Village Attorney to discuss how to approach the matter to best protect the interest of the Village.

Mayor Newhard urged Village Board members to look at the Homestead Village parking lot where equipment is currently stored, to see if there is any damage to the property.

3. Pump Track – Memorial Park.

Trustee McManus stated that the Lions Club would like to partner with the Village DPW to install a Pump Track. Discussion ensued about what a pump track is, what it consists of, how it is maintained and where it should be located.

Mayor Newhard asked Trustee Lindberg to work with Trustee McManus and Mike Moser to look at various locations for the Pump Track and report back to the Board of Trustees.

4. Outdoor Dining - Main Street Closure

Trustee McManus stated that due to Warwick Valley School Districts being open, the closure of Main Street for the purpose of outdoor dining must begin at 4:30 p.m. instead of 4:00 p.m. due to school bus traffic.

Mayor Newhard stated he will talk with Mike Moser and have the times adjusted.

5. Tax Assessor

Much discussion ensued about the role and hiring of a Village Tax Assessor. Mayor Newhard stated that some more homework must be done and seek more information throughout the County before moving on the motion in the agenda.

#### **Discussion**

Trustee Lindberg asked for some history on the resolution.

Trustee Cheney stated that after some research, according to the water billing clerk she does not remember ever charging these fees during her tenure. Trustee Cheney believed the charges were enacted in 1975 and possibly been replaced by land tax. So, when the transition to the land tax was made this may have replaced the debt service charges. The fee was used to pay off debt that had been incurred for the water system. Trustee Cheney stated that the fee may have been a relic from a long time ago and it has not been charged for over twelve years.
